World's Best Workforce

MN Statute 120B.11, adopted in 2013, requires that all Minnesota School Districts develop and implement a "process for reviewing curriculum, instruction and student achievement; striving for the world's best workforce."



2023-24 World's Best Workforce Goals

Each district developed plan must address these goals:

- 1. School readiness
- 2. Closing achievement gaps
- 3. College and career readiness
- 4. All students graduate

Note: the Literacy goal in previous WWBF reports was eliminated due to the READ Act. Literacy Goals are now part of the District Literacy Plan.



Goal #1 School Readiness

Measure A

The Delano School district will screen 100% of students entering Kindergarten prior to the first day of Kindergarten attendance.

Results for Measure A

Delano Public School screened 95% (149/157) of students entering Kindergarten prior to the first day of Kindergarten attendance. Goal not met



Goal #1 School Readiness

Measure B:

The percentage of students who were enrolled in our DPS Pre-School scoring in the Low Risk level on the eReading assessment will increase from 84.8% in 2023 to 87% 2024.

Results for Measure B

The percentage of students who were enrolled in our DPS Pre-School program and scoring in the lowRisk level on the eReading screener as a Fall 2024 kindergartner was <u>73%</u>. Goal not met







Goal 4: All Students Career and College Ready by Graduation

The District will increase the percent of students achieving CCR on the Reading MCA from 28.2 % in 2023 to 41% in 2024. Goal not met (37.4%)

The District will increase the percent of students achieving CCR on the Math MCA from 43.47% in 2023 to 56.08% in 2024. Goal Not Met (55.27%)





Context

A student who earns at least the CCR goal score in reading or mathematics on the MCA-III is expected to be able to successfully complete coursework in their respective subject without remediation. Students with MCA-III scores below the CCR goal score may need remediation prior to enrolling in a college credit-bearing course in the same subject at a two- or four-year college or university. The CCR goal scores were determined using spring 2015 data and are set at 1058 for Reading and 1152 for Math. In contrast the minimum score for Meets on the MCA is 1050 for Reading and 1150 for Math.



138 students in the class of 2024 took the ACT. ³ Class of 2024 participation rate is 78% (138/177 students)






In 2023-24, 221 Delano High School students took a total of 246 AP Exams with 78% of those earning college credit.



2024 Legislative Changes

Comprehensive Achievement and Civic Readiness

During the 2024 session, the Minnesota Legislature renamed WBWF to Comprehensive Achievement and Civic Readiness (CACR).

This new name emphasizes dual roles for the goals set forth in district plans—supporting students with academic achievement within their pre-K through 12 experience as well as preparing them to be active members of their community after graduation.

This change will take effect as of the 2024-25 school year strategic plans and Fall 2025 annual summary report.



2024-25 Comprehensive Achievement and Civic Readiness Goals

- 1. All children are ready for school
- 2. All racial and economic achievement gaps between students are closed.
- 3. All students are ready for career and college.
- 4. All students graduate from high school
- 5. Students are prepared to be lifelong learners.





Goal 1: School Readiness

Measure A

The Delano School district will screen 100% of students entering Kindergarten prior to the first day of Kindergarten attendance.

Measure B:

The percentage of students who were enrolled in our DPS Pre-School scoring in the Low Risk level on the eReading assessment will increase from 73% in 2024 to 80% 2025.





Goal 2: Closing the Achievement Gap among all groups

In 2024-25, within each subgroup (ELL, SPED and FRLP), we will increase the number of students who meet or exceed proficiency by 5% or more as measured by the 2025 MCA Reading and the 2025 MCA Math Assessments.

In 2024-25, we will increase the percentage of ALL students who meet or exceed proficiency on the 2025 MCA Reading and MCA Math Assessments by 5%





Goal 3: All Students are ready for career or college

The District will increase the percent of students achieving CCR on the Reading MCA from 37.4% % in 2024 to 41% in 2025.

The District will increase the percent of students achieving CCR on the Math MCA from 55.27% in 2024 to 57% in 2025.





Goal : All Students Graduate on time

In 2024-25, 100% of Delano High School seniors will graduate on time.





Goal 5: All students are prepared to be lifelong learners.

Multiyear goal

By the end 2028 school year, all grade 9 students will have developed an academic plan in Xello leading towards a chosen career or college path.

By the end of the 2028 school year, all graduating seniors will have taken a least two college level (AP, PSEO, or CIS) or career focused courses.
