**AGENDA ITEM:** Consider Approval of Resolution for Schools and Libraries Universal Services (E-Rate) for 2020-2021

**PRESENTER:** Earl Husfeld, Chief Financial Officer and Brooks Moore, Director of Technology

#### **BACKGROUND INFORMATION:**

- The Schools and Libraries Universal Service Program, commonly known as "E-Rate," is a federal program created in the late 1990s to assist schools and libraries with obtaining telecommunications, internet access, and information services.
- The E-Rate Program provides discounts of up to 90% to qualifying schools and libraries for eligible services and/or equipment and is administered by the Schools and Libraries Division of the Universal Service Administrative Company (USAC).
- Based upon E-Rate Program eligibility and funding guidelines, the District's current E-Rate discount amount is 50% of the competitively bid cost. This discount rate is based on the District's free and reduced lunch percentage and is the minimum discount set by USAC.
- The Aledo ISD has contracted with the firm of Kellogg and Sovereign Consulting, LLC to provide E-Rate Management Services to the District.
- The District will use this E-Rate funding to offset network infrastructure costs throughout the District, including 2019 bond related construction projects.
- The District issued a Request for Proposal (RFP) for network equipment in March and received four (4) responses. After evaluating all responses, Netsync Network Solutions graded best.
- The Resolution on the following page is required to be presented to the Board of Trustees for action in each year the District participates in the E-Rate Program.
- The Resolution authorizes filing of the Form 471 application for funding year 2020-2021 and the payment of the applicant's share upon approval of funding and receipt of services.

#### **FISCAL INFORMATION:**

The District's, or Applicant's, share (50%) of the funded services will be paid from 2019 bond funds for the related construction projects (technology portion).
