V. Reports

Executive Director Report

Federal Special Education Advocacy

As Past-President of MASE, Melissa Hanson joined MASE and MASA leaders in Washington, D.C. from February 26–28 to advocate for special education. The team met with all Minnesota congressional offices and the U.S. Department of Education to share successes, address funding concerns, and emphasize the importance of FAPE under IDEA.

OCR Letter on DEI

On April 3, the U.S. Department of Education’s Office of Civil Rights sent a letter to SEAs requiring certification of the elimination of DEI programs or risk Title I funding. MDE responded on April 7. The interpretation and implications of this directive remain unclear.

Supreme Court Case

A Minnesota case, A.J.T. v. Osseo Area Schools, will go before the U.S. Supreme Court in April 2025. The case challenges the legal standard for school district liability under Section 504 and the ADA, with potential implications for increased litigation and compliance.

Unite 2025 DAPE Event

MAWSECO is excited to host an inclusive DAPE Extravaganza for students from all seven member districts, organized by our DAPE teacher.

READ Act Training

Under the Minnesota READ Act, paraprofessionals who support reading instruction must receive state-approved training. MAWSECO is working with the regional service cooperative to ensure compliance, exploring both in-house and free training options.



Staffing Updates

Special Education Supervisor: MAWSECO and HLWW have completed interviews and successfully hired a new special education supervisor to serve the HLWW District.

SRO Partnership: Wright Technical Center has expressed interest in sharing MAWSECO's School Resource Officer. Discussions will prioritize program safety and explore cost-saving potential.

Custodial Services: With the Ed Center custodian on leave, Right-Way Cleaning has been contracted to provide interim custodial services.

Business Services: While the Director of Business Services is on leave, MAWSECO has contracted with CESO to maintain financial operations.

Program Administrator Report

Journeys, Step, and Trek Programs

End-of-Year Collaboration: Students are engaging in a 26-day initiative focused on practicing learned skills and fostering inter-program collaboration.

New Student Enrollment: Two students have recently joined the Education Center programs, and initial observations indicate positive progress.

Student Transitions: This academic year, five students have successfully transitioned, either fully or partially, from our programs back to their resident districts.

Journeys Program Enhancement: A regulation room has been added to the Journeys program. Students are utilizing the space appropriately, and the benefits are becoming evident.

Journeys Staff Update: Best wishes to Tehya Lehmann as she steps away to stay home with her son.

STEP Graduation: The STEP program will hold its graduation ceremony on May 23 at 10:00 a.m.

STEP Staff Retirement: Congratulations to Patty Diers on her retirement from the STEP program. We wish her all the best in her next chapter.



Cornerstones and Eastern Wright Programs

A new system has been implemented to support student reflection and discussion around inappropriate behaviors. An increasing number of Cornerstones students are earning incentive days compared to last year, with well-organized activities supporting this progress. One Cornerstones student is successfully participating in an automotive class through Wright Technical Center. One Cornerstones student has transitioned back to their resident district for 6 of 7 class periods. One Eastern Wright student has transitioned back to their resident district. One paraprofessional and one teacher have resigned to stay home with their children. Staff are doing excellent work to support these positive developments across programs.
