The Camera Bid packet has been read and reviewed and is fully understood. Pro-Vision will provide a full turn-key solution to the Knox County Schools, which includes new high-definition camera systems, required training and lifetime support.

The Pro-Vision Hybrid HD DVR (DVR-906) is capable of recording up to 8 channels of video all in TRUE 1080p video quality, and the 256GB SDXC card is more reliable than standard hard drives that require fans and heaters to function in the temperature environment common to Montana. The 256GB SDXC card provides storage of over 140 hours of run time or more than 4 average school weeks.

The internal cameras will include all the cabling and brackets to be mounted in the desired locations. The interior-mounted cameras meet your specification in that they provide a 180-degree horizontal field-of-view and a 90-degree vertical field-of-view. The Pro-Vision HD Dual-Lens Stop-Arm Camera will meet your specification in that it will provide a 90-degree horizontal field-of-view. The curbside camera will meet your specification in that it will provide a field-of-view of 150 degrees.

Additional subscription features like the Enhanced Connectivity Bundle (ECB-1YR) provide Automatic Contactless Wireless Video File Transfer and At-A-Glance System Health Monitoring over Wi-Fi. This can be added for a minimal annual charge of less than 20 cents per bus per day.






Forward Facing Camera (Road view through front Windshield)



This warranty applies only to a PRO-VISION® product (excluding BODYCAM® brand products) originally purchased from PRO-VISION, Inc. (the "company") after April 1st, 2017, that is sold to and shipped to an original end user customer located in the United States or Canada, which product is used and operated solely within the United States or Canada (a "covered PRO-VISION® product".
