My name is Matthew Wirtz, and I am a former student of the Lakeland School District, graduating in 2023. It has recently come to my attention that there was an alleged incident at Lakeland involving comments made about the death of political activist Charlie Kirk. I have heard from various sources that the teacher involved is Ms. Shannon Matilla, although this information remains unconfirmed.

I had the privilege of taking several classes with Ms. Matilla during my time at Lakeland High School. Additionally, I served as her teaching assistant, which allowed me to spend even more time working closely with her and observing her teaching style. Without a doubt, Ms. Matilla is one of the greatest teachers I have ever had. She has a remarkable ability to engage a classroom with both interest and laughter. Her deep understanding of complex mathematical subjects, such as calculus, and her ability to make them accessible to students is exceptional. Ms. Matilla challenged me both academically and through extracurricular activities such as BPA and math competitions. Teachers who make a lasting impact like she does are rare, and she was profoundly influential during my time at Lakeland—helping to shape me into who I am today.

I share these experiences as someone who knows Ms. Matilla's character first hand. She is not a malicious or hateful person in any way. On the contrary, she is one of the kindest and most caring teachers I have had the privilege to learn from. If she did make the alleged comments, I am confident they were not spoken with any ill intent. I believe this incident is simply an unfortunate misunderstanding.
