- Behavior Coach or Behavioral Intervention paraprofessional at the majority of MISD campuses
- Tiered RTI Behavior Interventions through the MTSS Handbook
- Partnership with local universities to utilize social work and LPC interns to assist students in meeting Social Emotional needs
- Partnership with mentoring and counseling entities to offer additional support to support students and families, including; local churches, Communities in Schools, KLARAS, TCHATT, Starry Counseling, National Alliance, Voices Against Substance Abuse (VASA), Unbound, and Methodist Home
- Substance Use Treatment Counseling for Students who failed Extra-Curricular participation drug tests
