Description:		
Sec.26.05(b) of the Texas Property Tax Code requires the Board of Trustees to adopt tax rates each school year. The tax rate consists of the following: Maintenance and Operations is \$0.97 and the Debt Service is \$0.48.		
Tax code Sec. 26.05(b) requires the use of specific language in making the motion to adopt the tax rates:		
"I move that the property tax rate be increased by the adoption of a tax rate of 1.450000, which is effectively a 3.34 percent increase in the tax rate."

RESOLUTION OF THE SOUTH SAN ANTONIO INDEPENDENT SCHOOL DISTRICT BOARD OF TRUSTEE TO SET TAX RATE

On this date, we, the Board of Trustees of the South San Antonio Independent School District, hereby levy or set the tax rate on \$100 valuation of the District for the tax year 2019 at the total tax rate of \$1.45, to be assessed and collected by the duty specified assessor and collector as follows:
\$0.97 for the purpose of maintenance and operations, and
\$0.48 for the purpose of payment of principal and interest on debts.
Such taxes are to be assessed and collected by the tax officials designated by the District.
THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.
