MEMORANDUM OF UNDERSTANDING

Between

BCFS Health and Human Services FAYS (Family and Youth Success) program

And

South San Antonio Independent School District

I. PARTIES

This Memorandum of Understanding ("MOU") is entered into by and between BCFS Health and Human Services ("BCFS HHS") and South San Antonio ISD (hereinafter collectively referred as the "Parties").

II. PURPOSE OF MOU

The purpose of this MOU is to describe the responsibilities of the Parties insofar as they relate to:

- Indicate a commitment and dedication to the implementation of the goals and objectives of the FAYS program.
- Make significant contributions to provide individual and family counseling, parent education, and case management services for South San Antonio ISD.

III. TERM, TERMINATION AND AMENDMENT(S) OF THE MOU

- a. **Term.** The term of this Agreement shall begin on June 1, 2021 and it will end on August 31, 2023, unless extended or sooner terminated as provided herein.
- b. **Termination.** The participation of either Party may be terminated without penalties or liabilities at any time during the Term by giving thirty (30) days written notice to the other parties.
- c. Amendment(s). Any alterations, additions, or deletions to the terms of this MOU shall be in writing and may only be executed by authorized representatives of BCFS HHS and South San Antonio ISD.

IV. RESPONSIBILITIES OF THE PARTIES UNDER THE MOU

A. BCFS HHS agrees to:

- 1. Accept all eligible referrals from South San Antonio ISD and will provide FAYS services as specified by its contract with the Texas Department of Family and Protective Services;
- 2. FAYS services may include individual counseling, family counseling, parent education, case management, presentations to students and school administrators.
- 3. Abide by all rules of use for South San Antonio ISD facilities, including times of entry and exit:

- 4. Face to face services will occur at South San Antonio ISD campuses, at our office located at 4346 NW Loop 410, San Antonio Texas, 79229, or a home visit(s) may also be conducted.
- 5. Virtual services will be available through use of HIPAA compliant platforms, as needed.

B. South San Antonio ISD:

- 1. Refer children and their families to BCFS HHS for FAYS services when a family is in need of individual, family, group counseling services, parent education, or case management.
- 2. Provide a space for parent education and childcare when needed, use of a confidential setting space for FAYS counselor(s) in order to provide services to families when needed.
- 3. Additional collaboration as jointly agreed upon in the future by both parties.

V. GENERAL PROVISIONS

The Parties to this MOU assume full responsibility for their respective costs associated with their performance of the terms of this MOU.

The Parties understand that each should be able to fulfill its responsibilities under this MOU in accordance with the provisions of the laws and regulations that govern their activities. Nothing in this MOU is intended to negate or otherwise render ineffective any such provisions or operating procedures. The Parties will assume full responsibility for their performance under the terms of this MOU.
