| February 15, 2021 | School Board meets to determine whether to approve and adopt a resolution issuing a proclamation calling for a special tax (SB9) election specifying (a) the date on which the election will be held; (b) the purpose for which the special election is called; and (c) the text of the ballot question(s) to be voted on [NMSA 1978, § 22-25-2(B)] |
| February 16, 2021 | School District files election proclamation in the office of the Lincoln County Clerk forthwith after adoption of resolution [NMSA 1978, § 1-24-2(A)] |
| March 23, 2021 ¹ | Lincoln County Clerk's first of two publications of election proclamation in the <i>Lincoln County News</i> [NMSA 1978, § 1-24-2(A)] |
| March 30, 2021 | Lincoln County Clerk's Second of two publications of election proclamation in the <i>Lincoln County News</i> [NMSA 1978, § 1-24-2(A)] |
| April 24, 2021 | Deadline for the Lincoln County Clerk to transmit ballots to federal qualified electors [NMSA 1978, § 1-6B-7, § 1-10-5] |
| May 11, 2021 | Deadline to register to vote in June 8, 2021 special school bond election [NMSA 1978, § 1-4-8(A)] |
| May 12, 2021 (Before May 14, 2021) | Lincoln County Clerk sends each registered voter a ballot along with a statement that there will be no traditional polling place for the election. The return envelope for the ballot shall be postage-paid. [NMSA 1978, § 1-24-3] |
| June 8, 2021 | Election Day (this date is a Tuesday) |
| June 14, 2021 | First day for county canvassing board (the Lincoln County Commission) to: (1) meet to approve the report of the canvass of the returns; (2) declare the results of the election and of all ballot questions |

¹ April 6, 2021 is the deadline for the Lincoln County Clerk to have published the election proclamation two times in the *Lincoln County News* [NMSA 1978, § 1-24-2(B)] specifying (a) the date on which the election will be held; (b) the purpose for which the special election is called; and (c) the text of the ballot question(s) to be voted on.

affecting only precincts within the county, and (3) issue a certificate of canvass of the results of the election and send one copy to: (a) the Lincoln County Clerk, (b) each local government with a candidate or ballot question (including the School District), (c) the Secretary of State, (d) the State Records Center, and (e) the State Canvassing Board [NMSA 1978, §§ 1-13-13(A), (B), and (C)]

June 18, 2021

Last day for county canvassing board (the Lincoln County Commission) to complete canvassing duties (see prior deadline) [NMSA 1978, §§ 1-13-13(A), (B), and (C)]

June 25, 2021

Suggested date for Superintendent to send a copy of the election resolution, filing certificate, affidavits of publication, and canvass with tally sheets to Antonio Ortiz, Public Education Department and to Brenda Suazo-Giles, Department of Finance and Administration.
