A brief discussion was held relating to information filed during the 84th Texas Legislative Session relating to intergovernmental transfers to the Texas Health and Human Services Commission for the non-federal share of Medicaid supplemental, waiver-related, and other payment programs in Texas. It was also noted if the mechanism does not satisfy federal rules and four counties fail to participate the entire program fails. Another mechanism would be to levy a fee and all hospital participate. If not, the program would revert to original Lease and Master agreements with its safeguards built into it.
