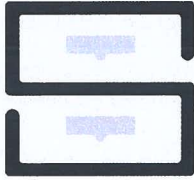

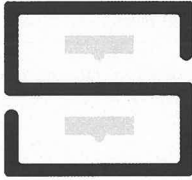

THIS AGREEMENT, made and entered this 30th day of October 2024 by and between STACKS CONSULTING LLC, referred to as the "CONTRACTOR", and the Riverside School District 96 located at 3340 S Harlem Ave, Riverside, IL 60546, hereinafter referred to as "The District", witnesseth:

1. Scope of Work. In consideration of the mutual promises hereafter specified, the Consultant and the District agree to the services delineated in the attached proposal, which document is incorporated by reference herein and made a part hereof.
2. Terms of Agreement. The term of this Agreement shall be from the date above through June 30, 2025 or the completion of the project, unless the term is extended by the mutual written agreement of the parties.
3. Compensation. As full and complete compensation for these services, the District shall pay the Consultant a fee of \$4,000, plus any hourly or optional components desired (additional pricing upon request) and reimbursables as detailed in the proposal, with the final cost determined by the number of additional services selected and associated travel costs, payable according to the following payment schedule:  
50% upon contract execution, 50% upon project completion, additional fees and balance due upon project completion/billing.
4. Signed Counterparts. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same document. This Agreement must be manually signed and may be delivered by facsimile or email (in .pdf format) and upon such delivery the facsimile or .pdf signature will be deemed to have the same effect as if the original signature has been delivered to the other Party.
5. The parties hereto shall abide by the requirements of Executive Order 11246 and the Rules and Regulations of the Illinois Department of Human Rights, and there shall be no discrimination because of race, color, religion, sex, national origin, ancestry, age, marital



status, physical or mental handicap unrelated to ability or an unfavorable discharge from military service in the employment, training or promotion of personnel engaged in the performance of this agreement.

This Agreement constitutes the entire Agreement between parties hereto. There is no part of that Agreement not set forth herein; and no changes in or additions to said Agreement shall be valid unless in writing and signed by the parties hereto.
