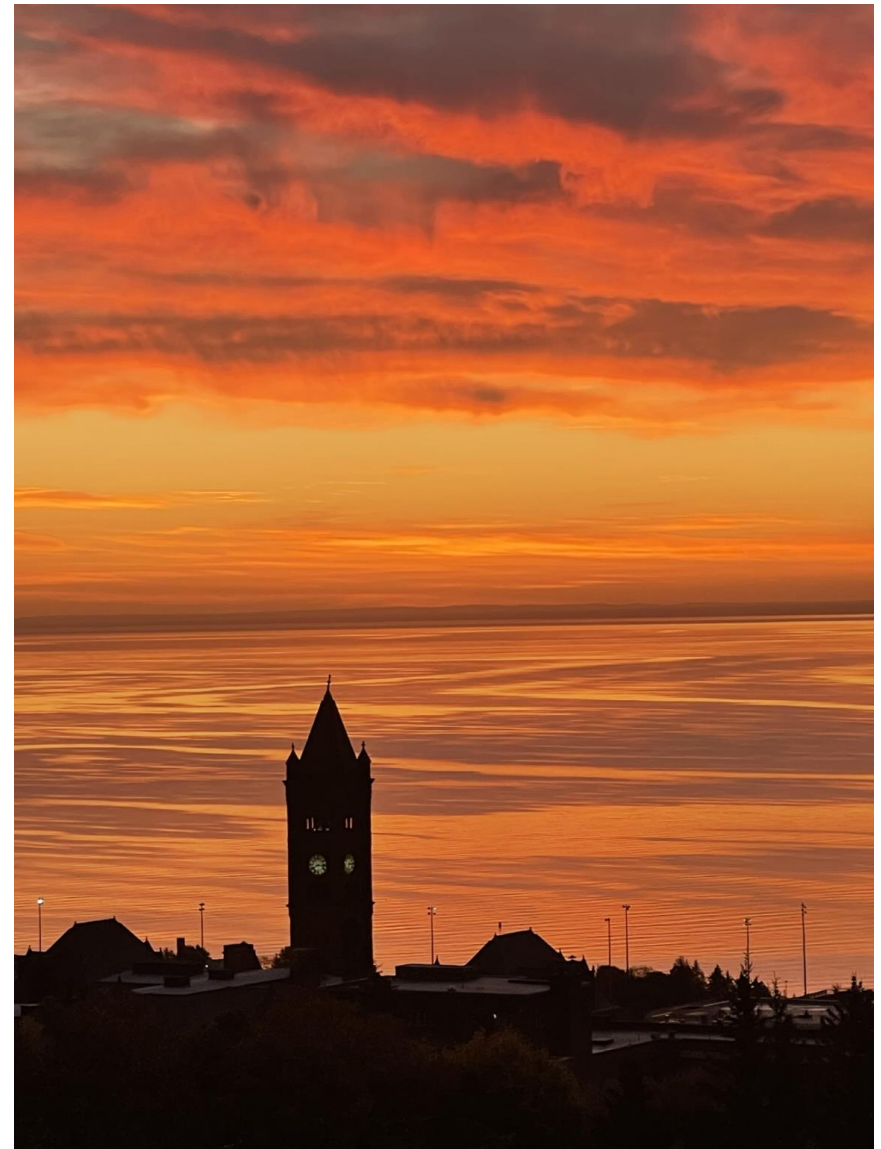

## **Testing Updates:**

We have received our state provided home test kits and are finalizing our communication and procedures for use. We have also applied for additional funding for testing for staff and plan to share more information for both of these programming in the near future.

## **Vaccine Update:**

We anticipate new guidance in the coming week related to vaccines for 5 to 11 year olds. We are optimistic that vaccinations could be up and running by the end of November. We will plan for voluntary vaccine clinics at our schools



# Safe Learning Plan 2021-22

## Quarantine Updates:

As the COVID pandemic continues, our schools continue to review and update response to ensure health and safety. The [Safe Learning Plan](#) reflects current local planning and is subject to change based on local, state and national guidance.

***Quarantine of Classrooms/Activity Groups:*** Following MDH Close Contact Guidance, MDH quarantine exceptions, current mitigation strategies in place, the impact of notification letters in raising awareness and with the current mask mandate in place, quarantine of individuals and/or the entire classroom/activity group and will be assessed and supported on a case by case basis.

# Safe Learning Plan 2021-22

## ***Close Contacts:***

- Students and staff identified as a close contact of someone who tested positive for COVID-19 and do not meet the quarantine exception criteria must quarantine for 10 days from the last date of exposure to that person.
- If symptoms develop during the quarantine period, the person identified as a close contact must be tested for COVID-19. A negative COVID-19 test will not shorten the quarantine period. Positive test results must be reported to the school health office. (Page 6)

# Safe Learning Plan 2021-22

## *Household Contacts:*

- If a household member has tested positive for COVID-19, unvaccinated household contacts must stay home and quarantine during the positive person's 10 day isolation period.
- The quarantine period for the unvaccinated household contact will extend past the 10 day isolation period for an additional 10 days.
- If symptoms develop anytime during the quarantine period, the household contact must be tested for COVID-19. A negative COVID-19 test will not shorten the quarantine period. Positive test results must be reported to the school health office.
- Vaccinated household contacts do not need to quarantine unless symptoms develop. If symptoms develop, the vaccinated household contact must stay home and be tested for COVID-19.

# Safe Learning Plan 2021-22

## Education During Quarantine

Members of the ISD 709 Teaching, Learning & Equity/COVID subgroup met to refine and clarify expectations for quarantine in regards to instruction. Providing educational services for students will be addressed in a way similar to an excused longer term illness.



# Safe Learning Plan 2021-22

## Elementary (K-5):

- Students will be considered having an excused absence while in quarantine.
- Teachers will initially offer up to 3 days of learning opportunities for students on any length of quarantine.
- Learning opportunities could consist of worksheets, activities, or at home suggestions and will be based upon reviewing prior content only.
- Students will not be required to return the work to school unless otherwise directed by the teacher.
- Students will not be participating in synchronous learning while quarantined with an excused absence.

# Safe Learning Plan 2021-22

## Secondary (6-12):

- Students will be considered having an excused absence while in quarantine.
- Use of Learning Management System (LMS) to continue learning opportunities (i.e. posting/turning in of assignments, discussion, etc.).
- Teachers should accommodate as needed for students/families requiring paper-based materials.
- Students will not be provided new instruction (synchronously or asynchronously) while in quarantine.
- Quarantined students will have accommodations for extended deadlines.

# Safe Learning Plan 2021-22

## Special Education Services

### **Homebound:**

In situations where an individual student or entire classroom or school is quarantined, homebound services may be offered to students receiving special education services by the case manager.

# Safe Learning Plan 2021-22

## Additional considerations:

- Employee and supply chain shortages continue in several areas are at critical levels
- Paraprofessionals, food service, transportation and custodial needs
- Use of spaces:
  - We considered expanding use of gym space at elementaries, but are unable to do so at this time
