## **ITEMS OF INFORMATION**

**Building Reports**: Mr. Gallup acknowledged the following building reports: KW Vina Elementary School - Toni Tatsey; Browning Elementary School - Sheila Hall; Napi Elementary School - Sicily Bird; Browning Middle School - Dennis Juneau; Browning High School - Jennifer Wagner; Babb Elementary School - John Salois; Big Sky/Glendale Colonies - Rebecca Rappold; Special Education Department - Rebecca Rappold; Buffalo Hide Academy - Matthew Johnson. *Discussion:* Mr. Evans stated he is glad to see attendance going up to 80% and asked if it is common for attendance to be that high at this time of year. Superintendent Hall stated the attendance is better now than the last couple years.

## **Superintendent Report**

Nafis Update 2023-2024: Superintendent Hall felt that this was one of the best conferences this year; the presenters were inspiring. Browning had good meetings with Tester and Zinke. Mr. Bremner felt the conference was good and was glad that he attended. Mr. Gallup stated Rosendale is a seated congressman and is one of the 8 that almost caused the government shut down; he also helped dethrone McCarthy. Mr. Gallup stated there are two bills introduced thanks to Browning and Indian lands; the construction bill was introduced on democratic side; there will be a continued resolution and advised all schools in Indian lands to push early payment requests. Browning did have a good response from Zinke; Matt will run against Tester and Indian country will work hard to make sure Tester stays in; COE is Republican and 100% for Indian lands.

Executive Committee Meeting Update: Superintendent Hall stated there was a round table from all over US; 90% of schools still need teachers; across nation. All working hard to work with states and educational systems to enhance across nation why it is important to be teachers. They talked about artificial intelligence and had to sign saying they wouldn't take pictures. Univ of Arizona looked at their data and there was no success in biology with first year students and they brought in virtual classes; like playing videoing games; they have higher retention rates. Superintendent Hall stated this is the future and she can see this helping kids learn to read; it is exciting and scary to see that this is how it will be in the future.

**BPS** Attendance Update: Superintendent Hall stated the highest day was 2,065 students. The average number of students today is at 1,947. The average number of students for BPS from the beginning of this school year is 1,998. On count day which is October 2, 2023 it was 1,947.

HR Status Report: Beverly Sinclair reviewed open positions: 1st grade open at KWV; 1 Tutor for 1st grade. BES 3<sup>rd</sup> grade teacher; elementary music teacher; custodian needs to be readvertised. Ms. Sinclair stated she is working on pushing some advertising. Napi needs elementary teacher for music; 1 science teacher; iTutor Sped; PCA-1, TA-1. BMS has a lead on a counselor; needs 1 elementary teacher for reading position; permanent consumer science teacher, 2 jr. academy teachers; 1resource teacher; transferred a custodian; 2 TAs; 1 BNAS teacher. BHS has a lead on a Business Ed teacher; 1 ELA Teacher; have an applicant for science teacher from Indeed; 2 TA; 1 PCA; 1 Drivers Ed. BHA needs 1 TA. Babb needs ½ TA and ½ Sped. PCOP FIT, Hiset, YDPH. The IT director position is posted on Indeed, frontline and OPI. There is some interest in this area. A/P has a recommendation for next agenda. Maintenance: needs1 electrician. Transportation needs 1 Radio Operator, a mechanic, a bus driver; two 9-month positions for drivers. Supper program position is available. Ms. Sinclair stated she would like to look into an employee referral program and stated that organizations have used this very successfully. Employees keep in touch via social media, and if can tap into our employees and get to the hard to fill positions it reduces costs and can get quality applicants; BPS can reward them with for bringing applicants our way (\$300-\$500). These programs do garner organizations some top-notch applicants and BPS can look here for teachers. Ms. YellowOwl stated that at the last board meeting Ms. Sinclair was asked to bring forward information to create a position for Human Resources department. Superintendent Hall stated that Gwyn Andersen asked that we hold off and Sandy Rivas has a plan to have her people help and make sure that the budget reconciliation is done before we add positions. Mr. Gallup stated he wants to get a budget to Board for review when Ms. Andersen returns. Ms. YellowOwl asked if the negotiations started. Superintendent Hall stated they start in January or February. Mr. Evans asked what 10% of people did not raise their hand that needed teachers; what did they offer that BPS doesn't. Superintendent will go back and find out; housing is one, social emotional health, recruitment, board/superintendent relations, this is throughout the nation. Ms. Sinclair stated that visas run out after 3 years and they go back.
