A huge thank you is extended to the many board members and administrators who attended the Impact Aid Summit sponsored by ASBA and Baboquivari Unified School District. It was a great day of information gathering and advocacy preparation.

The House Health Committee heard HB 2042 (S/E: schools; pupils with disabilities) passed as a strike-everything on a 7-0 vote. This bill allows

voluntary diabetes care assistants to administer insulin in addition to glucagon, assist the pupil with self-administration of insulin in an emergency situation or perform any combination of these actions under certain conditions. ASBA is neutral, with the understanding that a stakeholder's meeting has been called to address issues.

The House Appropriations Committee heard HB 2488 (200-day school calendar; funding.), which passed on an 11-0 vote. This bill allows individual schools and charter schools to offer 200-day calendars and increases funding under certain conditions for school districts and charter holders that offer an extended calendar. ASBA supports.
