Regular Board of Education Meeting
January 26, 2026 – 6:00 p.m.

1. Call to Order

President Burns called the meeting to order at 6:00 p.m. on January 26, 2026, at 1300 S. 109th Street, West Allis.

2. Mr. Keller led the pledge of allegiance.

3. Roll Call

Roll was called with the following members present: Joe Becker, Brendan Burns, Jane Carr (excused), Amy Deal, Brian Keller, Kristen Keyser (virtual), Rebecca Lee, Noah Leigh, and John Verbos.

4. Declaration of Public Notice

5. Modifications to Agenda

Dr. Robinson requested and was granted permission to add agenda item 11.3. February 2026 Extended Travel to Orlando, Florida.

6. Pershing Elementary School Student Showcase

Pershing Elementary School Principal Johnson and Instructional Coordinator Ms. Ellmann briefly reviewed the District's Theory of Action and how it connects to the learning that the students will be sharing. Third grade teacher Ms. Rosenbaum introduced students Ellis, Aiden, and Darius who demonstrated their reading skills using UFLI Foundations. President Burns and Dr. Robinson thanked parents, students, and staff for attending.

7. Superintendent's Report

7.1 Legislative Updates:

The senate scheduled its first and only floor action for January. This will feature several bills, including:

- **SB-391 School Bus Equipment:** Equipment of school buses with audiovisual recording devices.
- **SB-069 Tax Subtraction:** An income tax subtraction for certain expenses paid by a school teacher.
- **SB-371 Instructional Program:** Explaining pregnancy, prenatal development, and childbirth as part of a human growth and development instructional program.
- **SB-652 Higher Ed Programs:** Race-based higher education programs and requirements.
- **AB-457 Revenue Limits:** The conditions under which a school district may adopt a resolution to exceed its revenue limit.
- **AB-518 Substitute Teaching:** Allowing individuals who hold a substitute teaching permit to substitute teach at private schools participating in a parental choice program.
- **AB-592 Teacher Development:** Professional development for science teachers.

7.2 District Recognitions:

9.1 Review of Board Calendar

President Burns reviewed the Board calendar.

9.2 Board Committee Reports:

9.2.1 Communications & Engagement – Deal

Committee Chair Deal reported that the committee met on January 26, 2026. The committee reviewed strategic plan KPIs and noted strong progress in Facebook views and interactions, Instagram engagement, and newsletter open rates. All schools will display Strategic Plan posters, and the Communications team is exploring a captivate video to share the plan with the community. Carolyn will begin maternity leave on January 26, with Rachel Kruse and Alison Rageth covering district communications in her absence.

9.2.2 Financial Stability & Efficiency – Keyser

Committee Member Leigh reported that the committee met on January 15, 2026. The committee reviewed updates on the compensation model, consumer price index (CPI), high-cost claims, health insurance brokerage, state violence prevention grants, referendum finances, the 2026–27 preliminary budget, the Activity and Fitness Center, and the 2026 petition to detach.

9.2.3 Recreation & Community Services – Lee

Committee Chair Lee reported that the committee met on January 20, 2026. The committee received an update on memberships at the Activity and Fitness Center, gym hours, and the potential for a combined fitness center and open gym membership. The committee also reviewed program categories, affirmed the importance of continuing all current offerings, and discussed youth sponsorship opportunities and a potential community needs assessment.

9.3 Board Member Reports of Community Events:

- Ms. Deal attended the Wisconsin State Education Convention and noted the district showcased student talent from Hoover (podcast) and Central (robotics team), and a special shoutout to Dottke staff for hosting a successful exhibition night highlighting student learning.
- Mr. Leigh attended the Wisconsin State Education Convention, as well as the WASB Delegate Assembly to represent the District. Mr. Leigh provided an overview of the outcome of the WASB Resolutions and Bylaws. Mr. Leigh noted The Crucible runs this Thursday-Sunday at Nathan Hale, as Nathan Hale's Wrestling Team is having their last home dual meet this Thursday.
- Ms. Keyser thanked Mr. Leigh for standing up for kids for free and reduced lunches at the WASB Delegate Assembly.
- Mr. Becker attended the West Allis Taxpayer Association's monthly meeting and gave a shoutout to Mike Lukomski for his participation.

- President Burns attended the Wisconsin State Education Convention, the West Allis Central boys basketball game at Fiserv Forum, as well as the West Allis Taxpayer Association's monthly meeting.
