WHEREAS, the Riverside County Children and Families Commission (“Commission”) has entered into a Contract for Investment of Funds (“Contract”) with Inland Southern California United Way, Inc. (“Contractor”) for the provision of services;

WHEREAS, certain technology expenditures were excluded from the original CDSS funding, creating a funding shortfall, and

WHEREAS, the parties now wish to amend the Contract, to be effective as of **March 11, 2026**,

Now, therefore, the parties agree to amend the Contract as follows:

- A. The contract term is unchanged and remains: **October 25, 2023 - June 30, 2026**
- B. All references to the not-to-exceed amount shall be amended from \$2,208,600 to **\$2,313,871.12**, an increase of **\$105,271.12** for Technology Expenses.
- C. Attachment C: Budget as amended is deleted in its entirety and replaced with Attachment C-2: Budget.

All other terms and conditions of the Contract, including prior amendments, shall remain in full force and effect.
