Presentations/ Recognitions Woodrow Wilson Elementary has been named one of the top elementary schools in the state by the Texas Business and Education Coalition, which placed the school on its prestigious Honor Roll School list for 2009. This is the second year in a row for the school to receive this honor. The Texas Business and Education Coalition identifies Honor Roll schools by analyzing three years of performance data for every public school in Texas. A Texas Business and Education Coalition Honor Roll school must have a high percentage of students meeting state standards on every TAKS test for three consecutive years.

Discussion of Security Audit Report Theresa Grant, Director of Health Services presented the Board with a status report on Security Audit compliance, District accomplishments, and needed improvements for non-campus buildings. Ms. Grant also highlighted the District's collaboration in emergency management with city, county, and other municipalities. Senate Bill 11 from the 79<sup>th</sup> Legislature required school districts to implement a multi-hazard Emergency Preparedness Plan. It also required mandatory school drills to prepare students and employees for emergency response; emergency response training for all school district personnel; coordination between local emergency management agencies, law enforcement, and fire departments; security audits be conducted every three years in district facilities and the results of those security audits to be reported to Board of Trustees.

Discussion of Life Track Graduation Report Melanie Lewis, Director of Counseling presented the Trustees with the 18 month post-graduation data to the Board of Trustees for comparison to the 2007 exit survey. Denton ISD contracted with Life Track Services during the 2006/2007 school year to survey DISD's graduating seniors and follow up with an 18 month and a five-year survey. This survey will give DISD more detail about how students perceive their high school education impacting their lives. The information will also assist campus administrators, counselors and teachers and district planners in planning and developing programs that are relevant to real life experience.
