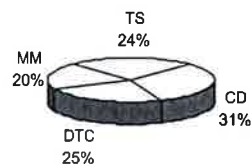

Portfolio Maturity Summary - Maturing \$/Month



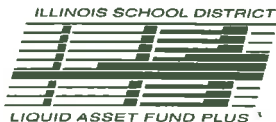
