# RESOLUTION AUTHORIZING FINAL AGGREGATE TAX LEVY FOR THE YEAR 2024

**WHEREAS**, the Board of Education of DuPage School District No. 45, DuPage County, Illinois ("the Board of Education"), is empowered to levy a tax on the real property within the DuPage School District No. 45, DuPage County, Illinois ("the School District"); and

WHEREAS, on November 12, 2024, the Board of Education estimated the property taxes to be levied for 2024; and

**WHEREAS**, based on said estimate and the aggregate levy adopted below, a notice or public hearing was required under the *Truth in Taxation Law*; and

**WHEREAS**, public notice of the Board of Education's intention to levy taxes in excess of 105% of the amount of taxes extended or estimated to be extended, exclusive of election costs and bond and interest costs, upon the levy of the Board of Education for 2023 was published on December 5, 2024, in accordance with the provisions of the *Truth in Taxation Law*, in a newspaper of general circulation in the School District; and

**WHEREAS**, the School District held a public hearing on the proposed tax levy on December 17, 2024 in accordance with the provisions of the *Truth in Taxation Law*.

**NOW, THEREFORE**, Be It Resolved by the Board of Education of the DuPage School District No. 45, DuPage County, Illinois, as follows:

<u>Section 1:</u> The aggregate property taxes to be levied for 2024, exclusive of debt service levies and levies made for the purpose of paying amounts due under public building commission leases, shall be as set forth in the Certificate of Tax Levy attached hereto and incorporated herein as Exhibit 1.

<u>Section 2:</u> The Secretary of the Board, or his or her designee, is authorized and directed to file with the Clerk of DuPage County on or before the last Tuesday in December 2024: a copy of this resolution, including Exhibit 1; and a copy of the Certificate of Compliance with the Truth in Taxation Law.

<u>Section 3:</u> All resolutions or parts of resolutions in conflict herewith shall be and the same are hereby repealed, and this Resolution shall be in full force and effect immediately and forthwith upon its passage.

# NOTICE OF PROPOSED PROPERTY TAX INCREASE FOR SCHOOL DISTRICT NO. 45, DUPAGE COUNTY, STATE OF ILLINOIS

I. A public hearing to approve a proposed property tax levy increase for School District No. 45, DuPage County for 2024 will be held on December 17, 2024 at 6:30 p.m. at the District 45 Board Room, 255 W. Vermont Street in Villa Park, Illinois.

Any person desiring to appear at the public hearing and present testimony to the taxing district may contact the District's Assistant Superintendent for Finance, Jeff Eagan, 255 W. Vermont St., Villa Park, Illinois 60181, telephone number (630) 516-7700.

II. The corporate and special purpose property taxes extended or abated for the year 2023 were \$42,459,191.01.

The proposed corporate and special purpose property taxes to be levied for 2024 are \$44,955,000.00. This represents a 5.88% increase over the previous year.

III. The property taxes extended for debt service and public building commission leases for 2023 were \$5,618,474.27.

The estimated property taxes to be levied for debt service and public building commission leases for 2024 are \$5,217,910.00. This represents a 7.13% decrease over the previous year.

IV. The total property taxes extended or abated for 2023 were \$48,077,665.28.

The estimated total property taxes to be levied for 2024 are \$50,172,910.00. This represents a 4.36% increase over the previous year.
