SUBJECT: Flooring Replacement

Bids were requested for replacement of flooring at both the Annex building and the Health Department building. One bid for each building was received.

The bid for the Health Department is from Young's Flooring in the amount of \$11,945.30. I would also like to do some painting in those areas receiving new flooring at a cost of approximately \$500.00. This cost is within the budgeted \$15,000.00.

The bid for the Annex building is from Young's flooring in the amount of \$21,332.50. I would further ask for an additional \$1,500.00 for the removal of a wall in the District Court jury room. This cost would be \$6,332.50 over the budgeted \$16,500.00 and would require a transfer of funds from 631-265-975.003 into 631-265-975.018.
