This *Cooperative Working Agreement is entered into between <u>Eagle Pass ISD</u> and the <u>Futuros Maravillosos</u> <u>YPS Program</u> of Serving Children and Adults in Need (SCAN), Inc. for the purpose of coordinating substance use and misuse prevention activities/services and referrals for students during FY 2020-2021. This Cooperative Working Agreement also serves to maximize resources by preventing the duplication of services.

SCAN, Inc. agrees to provide the following to the students at Eagle Pass ISD:

- 1. Positive Action curriculum lessons to students participating in the Futuros Maravillosos YPS Program.
- 2. Alcohol, Tobacco, and Other Drug (ATOD) positive alternatives and ATOD presentations to students and adult parents/guardians of students participating in the **Futuros Maravillosos YPS Program.**

Eagle Pass ISD agrees to:

- 1. Refer students between the grades of Kindergarden-12th to participate in **Futuros Maravillosos YPS Program** activities in person or virtually.
- 2. Work in conjunction with SCAN to ensure that program participants receive comprehensive substance use and misuse prevention services.
- 3. Provide an appropriate location for **Futuros Maravillosos YPS Program** Prevention Specialists to provide curriculum-based support group sessions at the school and or virtually.
- 4. Allow SCAN staff to provide at least one (1) or two (2) curriculum lessons per week of at least forty-five (45) minutes duration each to participating students.
- 5. Allow SCAN staff to complete required **Futuros Maravillosos YPS Program** forms, pre-tests, and post-tests for students participating in the program.
- 6. Provide occasional access to participating students in the classroom or virtually for brief presentations on alcohol, tobacco, and other drug issues and to participated in brief drug-free positive alternatives throughout the school year.

Furthermore, Eagle Pass ISD,

(1) Acknowledges that in receiving, storing, processing, or otherwise dealing with any information from SCAN, Inc. about the participants in the program, it is fully bound by the provisions of the federal regulations governing Confidentiality of Alcohol and Drug Abuse Patient Records, 42 CFR Part 2, and (2) undertakes to resist in judicial proceedings any effort to obtain access to information pertaining to participants otherwise than as expressly provided for in the federal confidentiality regulations, 42 CFR Part 2.

Terms and Termination:

The terms of this cooperative working agreement shall begin September 1, 2020 and will end on August 31, 2021.

Amendment and Modification:

This agreement may be amended by agreement of the parties above mentioned. Said amendment or modification will become a part of this agreement. In witness thereof, this cooperative working agreement has been executed by each agency's authorized representative on the dates listed below:

1. Youth is self-referred or is referred for services by a parent, teacher, counselor, etc.

2. A brief screening session is provided to make sure that the youth qualifies for program services.

3. If the youth qualifies for services and is willing to voluntarily participate in the program, a consent form is requested from the parent/guardian.

4. Each youth is provided an opportunity to participate in curriculum-based *Positive Action* lessons, and at least 1 educational, recreational, or cultural drug-free positive alternative activity.

5. Each youth's parent/guardian and/or other adult family members are provided opportunities to take part in drug prevention education sessions and drug-free positive alternative activities.
