The following is a sequence of events pertaining to the canvassing of the November 13, 2018 School Board of Trustees Election at an open public meeting:

1. In accordance with Section 67.004(a) of the Election Code states: "two (2) members of the authority constitute a quorum for purposes of canvassing an election." The Election must be canvassed at the earliest Friday, November 9, 2018 but no later than Tuesday, November 20, 2018.
2. The School Board Canvasses the results of the November 6, 2018 School Board of Trustee Election. The *Statement of Elected Officer Form* is provided to each newly elected trustee for signature at this time.
3. The winners of the November 6, 2018 School Board of Trustee Election are announced.
4. The newly elected Trustees are issued a *Certificate of Election*.
5. The newly elected Trustees take the *Oath of Office*.
6. The newly elected Trustees assume the duties of office.
7. As per School Board Policy BDAA (Legal) the board is reorganized
8. Finally, In accordance with Section 66.058 of the Election Code: the board takes action to destroy the ballots of the November 6, 2018 School Board of Trustee Election Twenty two (22) months (September 7, 2020) after the election.
