Building Report: Rizk said we have a lot of roofs going on. There have been five (5) new builds

and ten (10) sales in the last month.

Planning Report: Thompson announced the Planning Commission had a pond application that

was approved on Wilson Road between Linden and Webster Roads.

ZBA: Johnson relayed the Zoning Board of Appeals has nothing to report.

Library Report: Thompson reported the fiscal year ended June 30th with a fund balance of

\$19,536.92. We have a meeting Wednesday at 5:30PM.

Senior Center Report: SThomas announced there was an election of officers for the board.

Painting has been completed. Pasties are being sold now. The craft show and

bake sale will be on October 4th. The pole barn has been completed.

Fire Authority Report: Bryan announced the Fire Authority had Lieutenant Jeremy Kline celebrate

25 years with the Clio Fire Department. We will be discussing the self-contained breathing apparatuses tomorrow. We planned to replace these in 2026, unfortunately some of them are going bad now. The company we used

to use for parts has exited the fire service market.

BDA Report: Director Maxwell reported on August 14th will be fairy Tale Trail at Bridge Park.

We have 20 sponsors. Genesee County Master Gardeners are looking for volunteers to help with the butterfly garden. Thank you to Jill Freeman

Gardening Services for the flowers along the roads. We have started working on the 2026 budget. The Michigan Downtown Fall Conference is scheduled for November 5th through November 7th in Rochester. The Pure Michigan Byway Project is scheduled to resume Monday, September 8th, at the Flint Chamber of Commerce in downtown Flint. The Clio Chamber of Commerce will hold its monthly luncheon on August 14th at Clio Middle School. The next Chamber lunch will be September 11th and we will meet at the Fire Station. We will be

receiving news from the Township, so Joe will be speaking. We will also hear from Neil, from the City of Clio. The BDA meeting has been rescheduled to Monday, August 18th at noon.
