As has been past practice, the Board of Education approves, after review and recommendations from FAC (Facility Advisory Committee), capital projects to be undertaken. In October, 2012, the Board of Education approved the attached list of capital projects. Once approved by the Board, this work was given to the District's architectural firm, DLA Architects, to construct appropriate bid specifications and construction documents. Two bids (2013 Mechanical Upgrades and 2013 Masonry & Tuckpointing) were let on January 11, 2013 with appropriate legal notice appearing in the January 11, 2013 issue of the Oak Leaves. Such notice called for a pre-meeting for 10:00 a.m. and 11:00 a.m. respectively on Thursday, January 17, 2013 and bids due on January 29, 2013. A detailed letter from DLA Architects is attached describing the process, along with a summary of the bids received for both projects along with their professional recommendations.

The original bid estimate, exclusive of architect fees and any alternates, for the Mechanical Upgrade bid was \$703,500 and four bids were received ranging from the low of \$534,000 to a high of \$645,000. You will note that three of the bids were extremely close (between the low of \$534,000 and \$546,000). Further, the original bid estimate, exclusive of architect fees and any alternates, for the Masonry & Tuckpointing bid was \$258,195 and 11 bids were received, ranging from a low of \$197,800 to a high of \$520,000. Due to the significant variance between the low bidder, Bill's Painting Company and all other bidders, the architects met personally and discussed the scope of the project and all components of the work and, its representative, James Kokosoulis was confirmed in his ability to perform the services required. The architects further discussed prior work projects performed by this company with references provided and received positive feedback.

FAC is scheduled to meeting on February 19, 2013 and, as has been past practice, these bids and recommendations will be reviewed by them and then at the February 26, 2013 Board meeting, if any concerns are brought forward, they can be shared with the Board at that time. If FAC supports the recommendations provided this evening, then we would anticipate Board approval and award of these two contracts that evening.
