Mr. Ken Schulte made a motion that the Board of Trustees approve the certificate for resolution to amend and restate the prior authorization of the defeasance and redemption of certain outstanding bonds and that the Superintendent and Chief Financial Officer be designated as the authorized officer to identify the specific bonds to be defeased and to take such actions as may be required and necessary to effectuate such defeasance, seconded by Mr. Jerry Adkins. Motion carried 5/0.

B. Designate the Chief Financial Officer as the Calculator of the Tax Rate

Mr. Joe Rinehart made a motion that the Board of Trustees approve the resolution designating the Chief Financial Officer as the officer responsible for calculating the no-new revenue tax rate and the voter-approval tax rate for the current year, seconded by Mr. Jerry Adkins. Motion carried 5/0.

C. Tax Rate and Calculation Tax Year 2025

Mr. Chris Dunn made a motion that the Board accept the no-new-revenue tax rate and the voter-approval tax rate (formerly the effective or rollback tax rate) for tax year 2025 as recommended, seconded by Mr. Ken Schulte. Motion carried 5/0.

D. Adoption of the 2025-26 Budget

Mr. Jerry Adkins made a motion that the Board of Trustees vote to adopt the 2025-2026 state compensatory budget included in the proposed revenue and expenditure budget for the General Operating Fund, Child Nutrition Fund, and Debt Service Fund Budgets, seconded by Mr. Joe Rinehart. Motion carried 5/0.

E. Adopt Ordinance Setting the 2025 Tax Rate

Mr. Chris Dunn made a motion recommending that the Board of Trustees vote to adopt the attached ordinance setting the 2025 tax rate of \$0.8975 per \$100, with \$0.6822 per \$100 designated for the purpose of maintenance and operations, and \$0.2153 per \$100 designated for the payment of principal and interest on bonded indebtedness, seconded by Mr. Jerry Adkins. Motion carried 5/0.

Mr. Ken Schulte made a motion for the Board of Trustees to affirm the District's Vision, Mission, Beliefs, and Goals, seconded by Mr. Joe Rinehart. Motion carried 5/0.
