Lynne Rogers wishes to enter an agreement with our transportation department to provide summer transportation of students to and from the Summer Food Service Program at Lawndale School. The Boys and Girls Club – Haven Acres – will need 1-2 buses for breakfast and 2 buses for lunch. The Police Athletic League will need 1 bus for transportation at lunch. The summer food service program begins on June 2, 2008. The summer food service program will reimburse the Transportation Department for all regular costs of bus drivers (salaries & benefits) and fuel costs for transport of the students to and from the summer breakfast and lunch programs.

In the event of the contingency herein described, the Agreement shall terminate on the last day for which funds were available, without penalty or expense to Customer of any kind whatsoever, except as to payment for services or performances actually received or rendered for which funds exist.
