- **<u>24992</u>** <u>Meeting Called to Order</u>: Donna C. Smith, Board President, called the Board of Trustees Meeting to order at 6:00 p.m.
- **24993** Verification of Compliance with Open Meeting Law: Donna C. Smith, Board President, verified that the provisions of Section 551.001 of the Texas Government Code have been met in connection with public notice of this meeting.

24996 Special Presentations:

Superintendent Dr. Scott Muri Named Texan of the Year Finalist: Superintendent Dr. Scott Muri was recognized as a finalist for the Dallas Morning News Texan of the Year award. Dr. Muri had officially been on the job for just 62 days, as superintendent of schools when the mass shootings took place, forever changing our community. He had lived through Hurricane Harvey as the superintendent at Spring Branch ISD and, remarkably, that terrible situation had prepared him to navigate the response efforts to a wide-spread tragedy like ours. The editorial board of the Dallas Morning News noticed his efforts and named him one its finalists for its Texan of the Year award. He and El Paso ISD Superintendent Juan Cabrerra were two of the finalists – as you will recall El Paso experienced a mass shooting just one month before ours. This recognition is well deserved and we are proud to honor him for his leadership through this incredibly difficult time.

Odessa High School Band 81 Years of Division "1" Ratings: In the fall semester the Odessa High School Band earned a Division 1 Rating at the UIL Marching Band Contest. This marks 81 straight years that OHS has earned this achievement, the longest streak in Texas reaching back to 1939. OHS Head Band Director John Mayo and Associate Director Jimmy Olague were presented to receive the award. Unfortunately Associate Director Dave Polk was unable to attend. Congratulations, to the Bronchos Marching Band!

TMEA AII-State Musicians: The Texas Music Educators Association began the All-State Musician audition process in the fall, nearly 70,000 high school students across the state audition in their TMEA Region. Individual musicians perform selected music for a panel of judges who rank each instrument or voice part. A select group of musicians advances to compete against musicians from other Regions in their TMEA Area. The highest-ranking musicians judged at the Area competitions qualify to perform in one of 15 Texas All-State Bands, Orchestras, and Choirs. These All-State ensembles rehearse for three days, directed by nationally recognized conductors, and perform on the closing day of the annual TMEA Clinic/Convention. This year six Permian High School students earned this prestigious selection:

- Dillon Martin, a junior, plays saxophone in the band
- Javin Contreras, a junior percussionist in the band
- Damian Christian, a senior in Choir
- Raeslyn Miller, a senior in Choir, this is her second year in a row selected All-State Musician
- Justice Dominguez, a senior plays the flute in the band, and is a three-time All-State Musician
- Ashton Aranda, a senior in Choir, and this is her third year as an All-State Musician

DLR Innovation Challenge Students Presented at TASA Mid-Winter Conference: Four ECISD students participated in the Student Innovation Challenge sponsored by the DLR Group, an integrated design and architecture firm at Texas Association of School Administrators (TASA) Midwinter Conference. The Student Innovation Challenge is an inquiry-based learning event that includes collaboration and teamwork to solve a global challenge. Sophomores Ashley Manquero from OCTECHS, Quatre Haskins and Emily Banda from New Tech Odessa, and Rigoberto Mendoza from Odessa HS worked together on a research

topic ahead of the challenge, then continued the work with DLR Group mentors at the TASA Conference. At the end of the event, our students presented their response to the challenge during a session at TASA Midwinter. They represented our district well. Amy Koch from the DLR Group was in attendance for this presentation.

OHS Student Karis Cox Qualifies for National Thespian Festival: Odessa High School student Karis Cox for the third year in a row has qualified for the National Festival and Competition in June. The International Thespian Society (ITS), founded in 1929, is an honorary organization for high school theatre students located at more than 4,600 affiliated secondary schools across America and abroad. Each year the ITS holds a state festival in each of the participating states. The Texas Thespian Festival is one of the largest of these festivals with students attending three days of workshops and competition. While the state festival by itself provides a wonderful supplement to student education through workshops and competition, it also provides the opportunity for students to qualify for competition at the national festival.
