II. **Board Discussion**

- A. School Re-Entry Plan (Discussion/Action)

Mr. Driskell shared with the School Board the plan to bring back in-person hybrid learning starting on February 8, 2021.

Mr. Driskell has personally inspected every room on campus for cleanliness and safety. There will be required temperature checks done for every student. The School Nurse will go to the individual buildings if there is a student that needs to be seen. Surveillance testing will be done on 25% of the school staff every week, as mandated by the State. Students will not be allowed to use a locker for any reason. The restrooms will be used 1 person at a time. Students that choose to stay virtual with Edgenuity will be allowed to participate in extracurricular activities if

desired. They will use the back half of gym for social distancing at lunch. The State has given the option for schools to opt-out of the mandated State testing for this school year. The schools are required to give the option for parents to have their child tested if they are interested. Mr. Driskell said that the only test we will require is the SAT test.

Mr. Driskell shared a tentative calendar that the NMAA has shared for athletics. Fans will not be able to attend these events.
