### **DISCUSSION AND REPORT ITEMS – SUPERINTENDENT**

Dr. Brad Hunt, Superintendent delivered a message to the Board of Trustees and Coppell ISD that in recent days there have been several posts on social media that allege various instances of discrimination and/or harassment, including sexual harassment, related to students and employees at Coppell ISD. He stated that the safety and security of all students and employees at Coppell ISD is paramount. While he cannot provide specific information related to the allegations due to both employee and student privacy laws, he assured the Board and Coppell ISD that immediately upon learning of these allegations the District commenced multiple inquiries and investigations in accordance with District Policy. Dr. Hunt took the opportunity to state that Coppell ISD is committed to dismantling any racism, discrimination, and harassment within the District, and furthermore, employees and/or students will be held accountable for racist, discriminating, or harassing behavior. The District will follow our Board of Trustees' Policies with regard to these allegations, complete their investigations, and take any and all appropriate action permitted by and in accordance with both District Policy and State of Texas law.

### CONSENT

Tracy Fisher requested to remove item VIII 4 from the Consent Agenda for discussion.

David Caviness made a motion to approve the following consent agenda items as listed except for item 4:

- 2. Approve monthly 2019-2020 Budget Amendments
- 3. Approve Financial Report for June 2020
- 4. Approve 2020-2021 Appraisal Calendar and Second Appraisers
- 5. Approve Resolution to affirm the UIL's suspension of pre-participation physicals for the 2020-2021 school year

Nichole Bentley seconded the motion. The motion carried 7-0.

### **ACTION**

Tracy Fisher made a motion to approve the 2020-2021 Appraisal Calendar and Second Appraisers as presented. The motion was seconded by David Caviness and passed 7-0.

A motion was made by Anthony Hill and seconded by Tracy Fisher to approve the House Bill 3 Goals and Implementation Plan for Coppell ISD. The motion carried 7-0.

David Caviness made a motion to approve the modifications to the 2020-2021 calendar as presented. The motion was seconded by Anthony Hill and passed 7-0.

David Caviness made a motion to authorize the Board President, Secretary and Superintendent of Coppell ISD to execute all necessary documents to enter into an Agreement to purchase attendance credits to enable the district to reduce its local revenue level to a level not to exceed the level established under TEC, §48.257 for the 2020-2021 school year. Nichole Bentley seconded the motion. The motion passed 7-0.

A motion was made by Anthony Hill to delegate contractual authority to obligate the school district for the 2020-2021 school year under Texas Education Code (TEC) §11.1511(c)(4) to the superintendent, solely for the purpose of obligating the district under TEC, §48.257 and TEC, Chapter 49, Subchapters A and D, and the rules adopted by the Commissioner of Education as authorized under TEC, 49.006. This includes approval of the Agreement for the Purchase of Attendance Credits. Manish Sethi seconded the motion. The motion passed 7-0.

Nichole Bentley made a motion to approve the revised Order calling a School Board Trustee Election on November 3, 2020 be adopted as presented. Anthony Hill seconded the motion. The motion passed 7-0.

After discussion, the Board of Trustees made no endorsement for a Region 10 candidate for the TASB Board of Directors.

Tracy Fisher made a motion to postpone indefinitely the adoption of modifications made to the Board Operating Procedures Manual as presented. The motion was seconded by Anthony Hill. The motion failed 3-4. President Hulme; Vice-President Caviness; Trustee Sethi and Trustee Walker voted in opposition.

David Caviness made a motion to approve the revisions to the Board Operating Procedures Manual as presented. Manish Sethi seconded the motion. The motion carried 4-3. Secretary, Nichole Bentley; Trustee, Anthony Hill; and Trustee Tracy Fisher voted in opposition.
