ESSER III Grant Basics

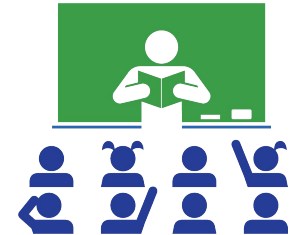
- The School District of Tomahawk will receive \$1,223,014.00 in ESSER III funding.
 - This money will be used to support our response to the learning loss and identified achievement gaps caused by the COVID-19 pandemic.
 - Funds are intended to help sustain the safe operation of schools and address the impact of the coronavirus pandemic on our students.

What is This Money For?

ESSER III Chosen EBIS: MLSS in Reading/Math/PBIS Supported by Wisconsin RtI Center.

This improvement strategy aligns with the mindset that every learner is important. We can reach this goal with careful and intentional structuring of our educational systems and refining the way we deliver instruction and support in the area of ELA. The allocation of 20% of our total ESSER III funds will focus on some of the strategies found below. We have defined that continuous improvement/strategic planning is an essential element in moving the work started in 2019 forward. These funds will focus on continuing to refine and implement the following structures at all levels within our district:

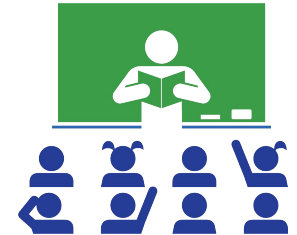
- Collaborative structures that allow planning for and responding to student needs

Continuation of supports from ESSER II

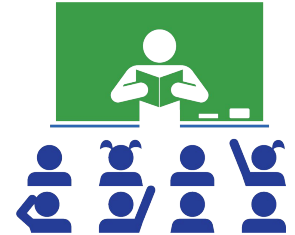
- One interventionist

Disproportionately Impacted Student Groups

Underrepresented subgroups specifically mentioned in USDE guidance as likely to have been disproportionately affected by COVID-19:

- each major racial and ethnic group
- children from low-income families
- children with disabilities
- English learners
- gender
- migrant students
- students experiencing homelessness
- children and youth in foster care
