Coach Terry Hoover has been a pillar of the Hanna High School tennis program since its inception, dedicating over four decades to shaping student-athletes both on and off the court. His coaching career began as a student coach at Texas A&I University from 1972 to 1975 before joining Hanna High School in the fall of 1975 as the head tennis coach.

Throughout his tenure, Coach Hoover built one of the most consistent and successful tennis programs in South Texas. When team tennis was introduced in 1992, Hanna qualified for the regional tournament every year except one—an impressive 32 out of 33 seasons. Additionally, individual players under his leadership have qualified for regional competition every year except for two, showcasing the strength and depth of the program.

Under his guidance, Hanna achieved four third-place regional finishes, and in 2012, the entire team qualified for regionals, marking a historic milestone for the school. His outstanding leadership and commitment to excellence earned him multiple **Coach of the Year** honors, solidifying his legacy as one of the most respected coaches in Texas high school tennis.

Coach Hoover retired in 2018, leaving behind a program rich in tradition, discipline, and achievement. His impact on Hanna High School tennis and the countless athletes he mentored remains a lasting testament to his dedication and passion for the sport.
