## Buffalo-Hanover-Montrose

### I. PURPOSE

The purpose of this policy is to establish broad curriculum parameters for the school district that encompass the Minnesota Graduation Standards and the federal No Child Left Behind Act and are aligned with creating the world's best workforce.

### II. GENERAL STATEMENT OF POLICY

The policy of the school district is to establish the "world's best workforce" in which all learning in the school district should be directed and for which all school district learners should be held accountable.

### III. DEFINITIONS

- A. "Academic standard" means a summary description of student learning in a required content area or elective content area.
- B. "Benchmark" means specific knowledge or skill that a student must master to complete part of an academic standard by the end of the grade level or grade band.
- C. "Curriculum" means district or school adopted programs and written plans for providing students with learning experiences that lead to expected knowledge, skills, and career and college readiness.
- D. "Instruction" means methods of providing learning experiences that enable students to meet state and district academic standards and graduation requirements.
- E. "Performance measures" are measures to determine school district and school site progress in striving to create the world's best workforce and must include at least the following:
  - 1. student performance on the National ~~Association~~ **Assessment** of Educational **Progress** where **applicable**;

2. the size of the academic achievement gap and rigorous course taking, including college-level advanced placement, international baccalaureate, postsecondary enrollment options including concurrent enrollment, other statutorily recognized courses of study or industry certification courses or programs and enrichment experiences by student subgroup;
  3. student performance on the Minnesota Comprehensive Assessments;
  4. high school graduation rates; and
  5. career and college readiness under Minn. Stat. § 120B.30, Subd. 1.
- F. “World’s best workforce” means striving to: meet school readiness goals; have all third grade students achieve grade-level literacy; close the academic achievement gap among all racial and ethnic groups of students and between students living in poverty and students not living in poverty; have all students attain career and college readiness before graduating from high school; and have all students graduate from high school.
- G. “Experiential learning” means learning for students that includes career exploration through a specific class or course or through work-based experiences such as job shadowing, mentoring, entrepreneurship, service learning, volunteering, internships, other cooperative work experience, youth apprenticeship, or employment.

#### **IV. LONG-TERM STRATEGIC PLAN**

- A. The school board, at a public meeting, shall adopt a comprehensive, long-term strategic plan to support and improve teaching and learning that is aligned with creating the world’s best workforce and includes the following:
1. clearly defined school district and school site goals and benchmarks for instruction and student achievement for all nine student categories identified under the federal 2001 No Child Left Behind Act and two student gender categories of male and female;
  2. a process for assessing and evaluating each student’s progress toward meeting state and local academic standards and identifying the strengths and weaknesses of instruction in pursuit of student and school success and curriculum affecting students’ progress and growth toward career and college readiness and leading to the world’s best workforce;
  3. a system to periodically review and evaluate the effectiveness of all instruction and curriculum, taking into account strategies and best practices, student outcomes, principal evaluations and teacher evaluations;

4. strategies for improving instruction, curriculum, and student achievement including the English and, where practicable, the native language development and the academic achievement of English learners; ~~and~~;
5. education effectiveness practices that integrate high-quality instruction, rigorous curriculum, technology, and a collaborative professional culture that develops and supports teacher quality, performance, and effectiveness.

B. District and site goals shall consider the following:

1. The school district's mission statement: *"Making a difference by preparing all students for a successful future in a changing world."*
2. All goals shall be in alignment with the district's core values:
  - ~~a. All students can learn, though at different rates and in different ways.~~
  - ~~b. We are in the business of lifelong learning. All of our actions must be measured by our success in achieving this goal.~~
  - ~~c. Maximizing learning requires innovation, risk-taking and the ability to change.~~
  - ~~d. All staff has a critical role in enhancing student development.~~
  - ~~e. Honesty, integrity, fairness and ethics in all aspects of the district.~~
  - ~~f. Continuous improvement is essential.~~
  - ~~g. Intolerance for anything short of the very best.~~
  - a. We foster an environment that develops and cares for the whole child.
  - b. All students can learn, though at different rates and in different ways.
  - c. We are dedicated to lifelong learning.
  - d. All learning requires innovation, risk-taking, and the commitment to continuous improvement.
  - e. All staff have a critical role in enhancing student development.
  - f. In all aspects of the district, we adhere to honesty, integrity, fairness, and ethics.
3. Measures assessing the effectiveness of district and site goals shall be measured against the school board adopted key ~~results~~ of:
  - ~~a. all students demonstrating academic growth and success;~~
  - ~~b. efficient and effective operations;~~

- ~~e. —safe, comfortable environment for everyone in our schools;~~
- ~~d. —increase student learning and expand instructional strategies by implementing technology;~~
- ~~e. —provide more instructional options at the elementary and middle school level.~~
- a. Each student explores strengths and passions through varied educational opportunities.
- b. Each student demonstrates academic growth and success.
- c. Student learning and engagement are optimized through high-quality and innovative instructional strategies.
- d. Everyone in our schools experiences a safe, comfortable, and caring environment.
- e. The district operates efficiently and effectively.
