A Regular Meeting of the Board of Trustees of United ISD was held on Wednesday, March 20, 2013, in the Bill Johnson Student Activity Complex, Fine Arts Building, 5208 Santa Claudia Lane, Laredo TX 78043. President, Judd Gilpin made an announcement calling the meeting of the United Independent School District to order at 6:05 p.m. The record showed that a quorum of Board members was present, that the meeting had been duly called, and that notice of the meeting had been posted in accordance with the Texas Open Meeting Act, Texas Government Code Chapter 551.

If not, the person shall be directed to the appropriate policy, as noted in BED (LOCAL), to seek resolution before bringing the matter to the Board at a subsequent meeting. Pursuant to 551.042 of the Texas Government Code, no Board Member or Administrator may respond to a member of the public, unless such response is a recitation of District policy or a statement of

specific factual information. When a speaker comes to the podium, please indicate what agenda item you will be addressing. Furthermore, please refrain from mentioning any employee's name and any complaint about any employee's duties or responsibilities should be channeled through the appropriate grievance policy.

Abdul Mohammed – spoke on Item IV-C – Recognitions – Mr. Mohammed introduced himself and stated he is the father of Ayeesha Mohammed, Alexander High School swimmer who went to state meet in Austin. He stated he is also the head coach for the Laredo Tritons Swim Club. He thanked the board and Coach Bobby Cruz for the support they have provided to the district's aquatic program as it continues to grow. Mr. Mohammed said he would also like to call for the board to consider an aquatic center that can hold swim competitions. He stated they currently have over 150 swimmers in the Laredo Tritons Swim Club and it is the feeder program for the district's swim teams. He mentioned there are over 120 swimmers in all the high schools that use that one facility. He asked for the board to consider a new facility where swimming competitions can be held here in Laredo so they won't have to do as much travel. He mentioned he had with him some of the parents of the high school swimmers, board members of the Laredo Tritons Swim Club as well as the coach and assistant coach of the high school program. Mr. Mohammed thanked the board for their time.

Mr. Judd Gilpin thanked Mr. Mohammed for all the work he does for the community.

Mr. Santos addressed the board and announced that the ITV Department had prepared a video for Board Appreciation Month.

Ms. Susan Carlson addressed the board and gave a brief summary of the video and explained that due to the complexity of the video they were not able to have it ready on time. She also stated that in February, she and her staff were in Corpus Christi receiving their TSPRA awards and mentioned that last year's board appreciation video "The Genie and the Seven Wishes" won a gold star award.

Mr. Santos thanked Ms. Carlson and her staff for putting the video together and thanked the board on behalf of the 43,000 students and 6,000 employees, for the job that they do for United ISD.
