

Statement of Work - Server Refresh

Project Background

Our client, Belmond-Klemme Community School District, is currently running a Windows Server environment on various versions of the operating system as well as older hardware which is no longer covered under a manufacturer's warranty. All this creates a risk scenario for the client's network as many of the operating systems will no longer receive patches for newly discovered vulnerabilities, bug fixes, or Microsoft support. This can make it a prime target for attackers looking to exploit known weaknesses. When running server hardware with an expired warranty, there are also risks. The most obvious risk is that the client won't have access to the manufacturer's warranty protection. If hardware components fail or experience issues, the company won't be able to rely on the manufacturer to repair or replace them at no cost. This means they will be responsible for any repair or replacement costs, which can be significant for server hardware.

Project Objectives

The primary objective of this project is to install new server hardware running the latest Windows Server operating system on current server hardware covered by a manufacturer's warranty including a new UPS, migrate all data and services over to the new server, and finally to decommission the current server. Additionally, the client's administrative environment will be migrated from the on-premises Active Directory domain to the Microsoft cloud-based Entra ID for all computers and users and the data migrated to a local NAS appliance.

Implementation

Visual Edge IT will:

- Procure, prep, and deploy a new Uninterruptible Power Supply to power and protect the new server hardware
- Procure, prep, and deploy a new Windows Server 2022 Standard on new HPE server hardware
- Migrate all network and domain services from source school servers to target server
- Migrate all data and shared resources from source school servers to target server
- Migrate all applications and application data from source school server to target server including any assistance needed by each software support vendor
- Reallocate backup services from source school server to target server
- Procure, prep, and deploy a Network Attached Storage appliance (NAS) to the Administrative building network
- Migrate all Administrative office data from source servers to the target NAS
- Configure Entre ID including Intune policies with input from the client
- Migrate all targeted Administrative computers and user accounts over to Microsoft Entra ID and enroll into Intune
- Migrate all Administrative network services to the network firewall
- Ensure all users retain access to the local resources where applicable
- · Demote and decommission all source servers

Required and Unplanned Down Time

- There will be required downtime during this project as all server resources and services will be migrated to a new on prem systems and a portion of users and computers migrated to the Microsoft cloud
- VEIT Project Implementation Team will coordinate with the client Point of Contact for windows of downtime
- VEIT Project Implementation Team will work to restrict downtime during non-critical hours, when possible, this may include after-hours
- VEIT Project Implementation Team will do everything to prevent unplanned downtime
