

Member _____ introduced the following resolution and moved its adoption:

RESOLUTION PROPOSING TO PLACE
KARI SKEEN-LENZMEIER
ON UNREQUESTED LEAVE OF ABSENCE

BE IT RESOLVED by the School Board of Independent School District No. 877, as follows:

1. That it is proposed that Kari Skeen-Lenzmeier, a Media Specialist of said school district, be placed on a .206 FTE unrequested leave of absence without pay or fringe benefits, effective at the end of the 2020-21 school year on June 30, 2021, pursuant to Minnesota Statutes section 122A.40, subdivision 10, along applicable portions of ARTICLE VI, Section 3, Subdivisions 1-6 of the current Master Agreement between the School District and the exclusive representative, based upon the following grounds: financial limitations and reduction of position.
2. That said proposed placement on unrequested leave of absence is not the result of the implementation of an education district agreement.
3. That written notice be sent to said teacher regarding the proposed placement on unrequested leave of absence without pay or fringe benefits as provided by law and said notice shall be in substantially the following form:

Dear Ms. Skeen-Lenzmeier:

You are hereby notified that at the regular meeting of the School Board of Independent School District No. 877 held on April 26, 2021, consideration was given to your placement on unrequested leave of absence without pay or fringe benefits for .206 FTE of your position as a Media Specialist of Independent School District No. 877, and a resolution (copy enclosed) was adopted by a majority vote of the Board, proposing your placement on unrequested leave of absence for .206 FTE of your position effective at the end of the 2020-21 school year on June 30, 2021, pursuant to Minnesota Statutes 122A.40, subdivision 10, along with applicable provisions of ARTICLE VI, Section 3, Subdivisions 1-6 of the current Master Agreement between the School District and the exclusive representative. The grounds for your placement on an unrequested leave of absence are: financial limitations and reduction of your Media Specialist position.

Your proposed placement on unrequested leave of absence is not the result of the implementation of an education district agreement.

Under the provisions of the Master Agreement between the School District and the exclusive representative, you are entitled to a hearing as set forth in Minnesota Statutes section 122A.40, subdivision 14, before the school board provided that you make a request in writing within fourteen (14) calendar days after receipt of this notice. If no hearing is requested within such period, it shall be deemed acquiescence by you to the School Board's proposed action.
