PURPOSE

What Are 1882 Partnerships?

- Senate Bill 1882, known as the TX Partnerships Law, was passed in 2017.
- SB1882 establishes incentives for districts to enter into partnerships:
 - Grant opportunities
 - State accountability exemptions
 - Increase in funding (~\$1,500)
- Districts can create partnerships with nonprofits, public IHEs, and gov. entities

How Are 1882 Partnerships Structured?

- Districts maintain **ultimate responsibility** over the partnership through negotiated **performance measures** and **financial goals** in the contract.
- 1882 Partnership schools are
 - still district schools
 - o students at a Partnership school remaindistrict students
 - the campus's accountability gain scount for the district's accountability.

How Are 1882 Partnerships Structured?

- Governed by the partner's board
- Decision making rights remainas close to the students as possible
- Partner has sole autonomy over:
 - Staffing
 - Curriculum
 - Budgets
 - Calendar
- Ultimately, districts have the authority to monitor and provide oversight
- Districts may extend the charter term
- Districts may revoke the partnership charter if goals are not met.








We also have our Education Preparation Program (EPP) which oversees our teacher candidate field placements, clinical teaching experience, and teacher certification.




What specific benefits could Texas A&M SA provide South San Antonio ISD?

- Faculty in Residence-Assign a professor to the SB 1882 site to support teacher development and to help advance student outcomes
- Clinical Teacher Placements We will provide funding to A&M-SA students to conduct yearlong clinical teaching placements for our SB 1882 partnerships. This provides a more consistent model for the South San Antonio students.
- Professional Development Support We will leverage the resources of the university to provide professional development to support staff and increase capacity
- Graduate Education for Teachers We will use a portion of the SB 1882 funds to provide scholarships for teachers to pursue master's degrees.

Appendix: What are terms to know?

Authorizer

The entity that engages a charter operator to manage schools and oversees the performance of that partner for the term of the charter. This is either an Independent School District or TEA.

Authorize

The act of granting authority to a charter operator to assume governance of a school.

Operator

The non-profit entity that is authorized to assume governance of a school. Sometimes referred to as a "partner."

Call for Quality Schools

The process by which an authorizer vets potential charter operators for a partnership. The CQS should include a written application and a capacity interview.

Performance Agreement

The contract between the authorizer and the operator that outlines the terms of the partnership and establishes metrics to which the operator will be held accountable.
