Board Policy 4:80 - Accounting and Audits, designates specific individuals who have authority to sign checks on behalf of the District. The policy states, "The Superintendent or designee and Assistant Superintendent for Finance and Operations, School Treasurer, or Fiscal Service Coordinator shall sign all checks issued by the School District, except that checks from an account containing student activity funds and revolving accounts may be signed by the respective account custodian."

In May, the administration brought forth a recommendation for a change in signatories due to the transitions in the finance office. Currently Dr. Kelley, Laurie Campbell, and Mark Sheahan have been serving as signatories on the various accounts. Now that Mr. Patrick King has started as Director of Finance and Mr. Mark Sheahan is being recommended as interim Chief School Business Official, it is time to move the signatory responsibilities back to the finance office.

We are recommending that Patrick King and Mark Sheahan serve as the signatories on the District's accounts with Prudent Man Advisors (PMA), Community Bank, and BMO Harris and that Dr. Kelley and Laurie Campbell be removed as signatories. A list of the accounts and respective signatories are attached for your review.
