An approximate 70.00 acres of land located in the J.R. Arocha Survey 171, Abstract 2, Kendall County, Texas and out of that called 104 acres of land as described in Volume 1617, Page 1095, of the Official Public Records of Kendall County, Texas ("Property"); and

**WHEREAS**, the Superintendent has been authorized to enter into a real estate sales contract (the "Contract") with the owner of the Property for purchase of the Property by the District; therefore,

## Be it resolved.

- 1. That the findings and recitals in the preamble of this Resolution are hereby found to be true and correct and are hereby approved and adopted.
- 2. That the Board of Trustees of the Boerne Independent School District approves and authorizes the purchase of the Property described herein under the terms described in the Contract as finally negotiated.
- 3. That the Superintendent or her designee is authorized to tender the purchase price of the Property and the amount of closing and other costs to the title company for payment to the Seller of the Property and to execute any documents necessary to effect the purchase.
- 4. That it is hereby found, determined and declared that sufficient written notice of the date, time, place and subject of the meeting of the Board of Trustees of the Boerne Independent School District at which this Resolution was adopted was posted at a place convenient and readily accessible at all times to the general public for the time required by law preceding this meeting as required by Chapter 551, Texas Government Code, and that this meeting has been open to the public as required by law at all times during which this Resolution and the subject matter thereof has been discussed, considered and formally acted upon. The Board of Trustees further ratifies, approves and confirms such written notice and posting thereof.
