Current Fiscal Activity

During July 2026, the Business Office focused on closing the 2025–2026 fiscal year while preparing for the start of the 2026–2027 fiscal year, including setting up accounting records and processing payroll. 2025-2026 Fiscal Audit will begin on 08/20/2026 with our on-site audit.

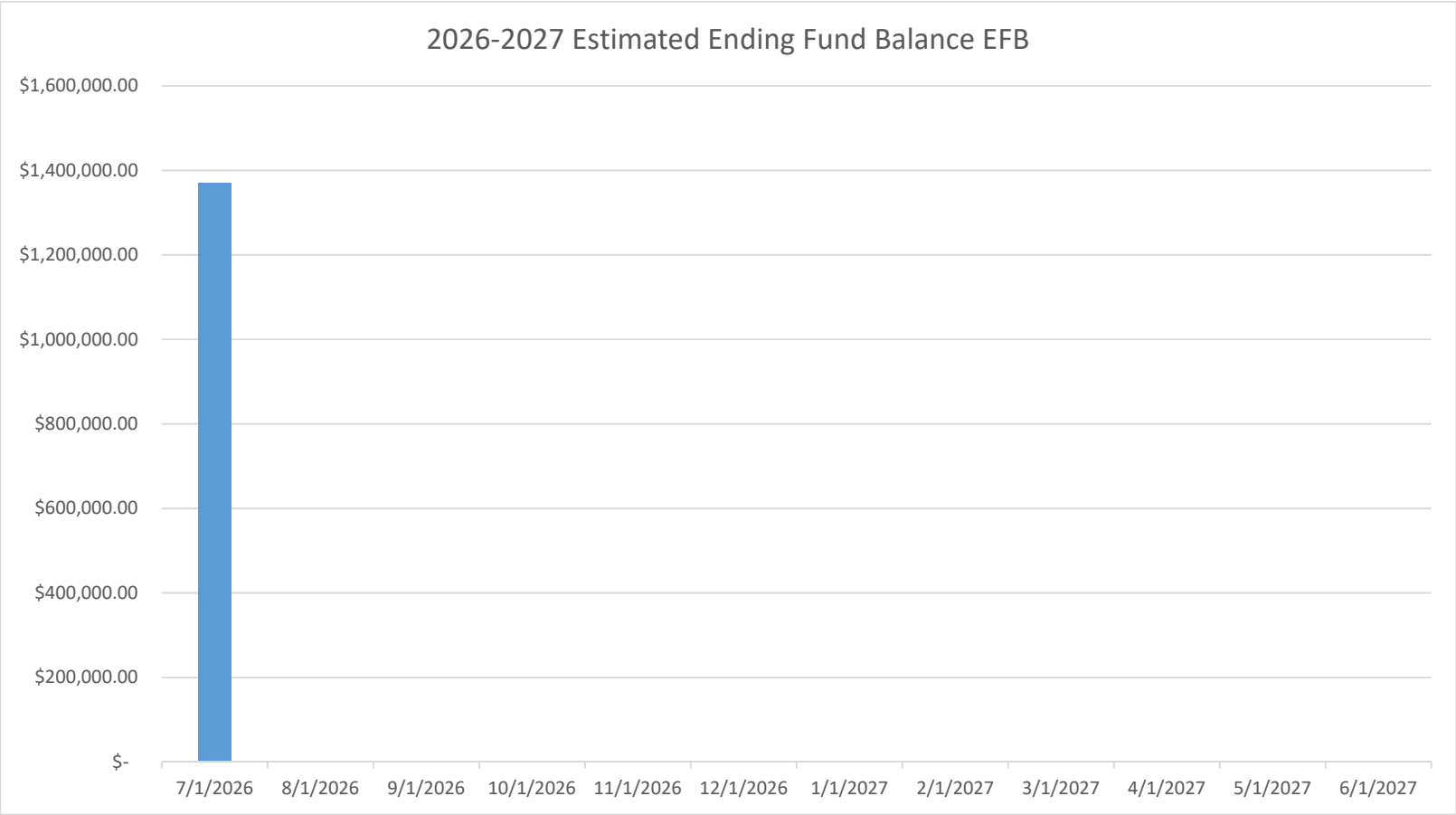
Food Service: Summer Lunch Program
