JUSTIFICATION:	Best value. Pricing is based on a percentage discount off the manufacturer's suggested retail price (MSRP) and on hourly rates for installation and repair services. Products and services are ordered on an as needed basis. Not to exceed pricing is based on historical usage. The majority of the audio visual products that the District purchases require installation from a company certified by the manufacturer to install their product. From the ten responses, Lantek and Videotex provide the best overall value to the District. Both companies have certified installation teams for all products installed at Collin College. TFE, while providing a higher discount on a couple of manufacturers, are more than double the price for hourly installation and repair services than the recommended vendors. Summit Integration Systems has a poor installation performance history on several projects with the District and they do not have Extron certified technicians and the Extron Pole Vault System is the standard specification for full media solutions in the classrooms Awarding to two vendors provides the ability to rely on both during busy seasons of the year when one or the other may not have adequate staffing or availability.
