Proposed 2009-2010 Elementary & High school Attendance Zones
May 13, 2008

SUMMARY:

- The Superintendent directed district staff to develop proposed elementary and high school attendance zones to establish boundaries for Stephens Elementary & relieve over-crowding at Guyer High School in 2009-2010.

PREVIOUS ACTION

- Board Workshop - DISD staff provided the Board with rezoning information on the proposed 2009-010 attendance zones for elementary and high schools April 22, 2008.

BACKGROUND INFORMATION:

- Proposed 2009-10 Elementary & High School Attendance Zones – *See Attachment #1*

SIGNIFICANT ISSUES:

- Review and adjust attendance zones to relieve campus overcrowding.
- Determine impact of zone changes on elementary and secondary campuses.
- Establish new high school zones that facilitate the development of a future high school attendance zone.
- Determine impact of zone changes on future elementary and secondary school sites.
- Review transfer policies and make recommendations to maintain attendance zones.
- Review student assignment polices to manage capacity issues.
- Minimize movement and dislocation of students.
- Balance district program services.
- Establish clear and definable attendance boundaries.
- Reduce school operational costs.

FISCAL IMPLICATIONS:

- Establishment of new attendance zones will relieve overcrowding on elementary campuses within the district's southeastern service areas and at Guyer High School.
