BACKGROUND:

Administration is requesting approval of Resolution No. 002/25-26 to participate in the purchasing programs of The Local Government Purchasing Cooperative (TASB) for fiscal year 2025-2026. Participation in this purchasing program facilitates the benefit of volume purchasing that result in anticipated savings to the district. This cooperative will access a processing charge of \$400.00 for small sized motor vehicles and \$800.00 for large sized motor vehicles per purchase order regardless of the number of vehicles being purchased. This charge is levied on the end user and collected by contractor. No additional fees are accessed to participate in this cooperative.

Amount expended for the previous 12 months: Fees small vehicles - \$0.00 and large vehicles \$800.00. Annual Transactions - \$4,953,532.87.

\$4,953,532.87 (Amount expended – previous 12 months)
x 7% (Estimated increase as per current market trends)
\$5,300,280.17 (Estimated annual usage)


