



#### APPOINT BUDGET COMMITTEE MEMBERS TO FILL VACANCIES

#### **POLICY ISSUE / SITUATION:**

The Budget Committee has three vacancies:

- Zone 1 (Susan Greenberg): McKay, Montclair, Raleigh Hills K-8 and Vose elementary schools, Whitford Middle School and Beaverton High School.
- Zone 2 (Anne Bryan): Bethany, Findley, Jacob Wismer, Oak Hills, Rock Creek and Springville K-8 elementary schools, Stoller Middle School and Westview High School.
- Zone 6 (Jeff Hicks): Greenway, Hiteon, Nancy Ryles, Scholls Heights elementary schools, Conestoga Middle School and Southridge High School.

#### BACKGROUND INFORMATION:

The School Board needs to appoint community representatives from Zones 1 and 2 to serve three year terms and a representative from Zone 6 to serve a one year term on the Budget Committee.

The School Board decided on the following process during the August School Board Meeting:

- Publicize the openings as broadly as possible using all communication channels in September
- · Request a letter of interest and resume from each candidate
- Each Board Member would interview candidates for their zone in October
- Present appointee at the October 27, 2014 School Board Meeting for Board approval
