

### Required Professional Development in Scientific Reading Instruction

Beginning with the 2018-19 school year and provided on an annual basis thereafter

# Completion of a pathway to proficiency:

K-6 teachers in core content areas

- Math
- Science
- Social studies
- English language arts

#### K-12 Special Education teachers

Completion of a pathway to awareness:

All other other licensed teachers

# Pathways to Proficiency require two phases:

- Phase 1 is professional learning
- Phase 2 is demonstration of knowledge and practice through testing or observation by certified assessor

# School-based Literacy Plans

Beginning with the 2019-20 school year and provided on an annual basis thereafter

All public school, including open enrollment charter schools shall include a literacy plan in the school-improvement plan that shall include a curriculum program and a professional development program

- Aligned with literacy needs of the district
- Based on the science of reading

These improvement plans are required to be posted on the district website no later than September 1 each year


## **Proficiency and Awareness**

By the beginning of the 2023-24 school year and each year following


#### All teachers employed in the following teaching positions shall demonstrate proficiency in knowledge and practices of scientific reading instruction:

- Elementary school teachers in grades K-6 teaching math, science, social studies or English language arts
- K-12 special education teachers
- Teachers of English Language Learners in grades K-6 (added by rule in 2019-20)
- Reading specialists (added by rule in 2019-20)

All other educators shall demonstrate awareness in knowledge and practice of scientific reading instruction.

# Awareness of Knowledge and Practice

By the beginning of the 2023-24 school year and each year following

# All other educators shall demonstrate awareness in knowledge and practice of scientific reading instruction.

Any educator whose license expires on December 31, 2023, or after, must have an awareness credential to renew his or her license.

# • Currently, there are 12,827 educators who have been coded for awareness in the state.

## **Educator Preparation Programs**


Beginning in May 2023

A person who completes a state-approved EPP leading to Elementary K-6 or Special Education K-12 licensure shall have proficient knowledge and skills to teach reading consistent with the best practices of scientific reading instruction. This includes:


- Those seeking an Elementary K-6 or Special Education licensure
- Those adding an Elementary K-6 or Special Education licensure by reciprocity.

All other persons completing a state-approved EPP, graduate program, or alternative preparation program shall demonstrate an awareness of the best practices of scientific reading instruction.

# **Program Evaluation and Approval**

By the beginning of the 2020-21 school year

The Division shall identify an approved list of materials, resources, and curriculum programs that are supported by the science of reading and based on instruction that is explicit, systematic, cumulative, and diagnostic. Programs include:

- Evidence-based reading intervention programs
- Evidence-based reading programs
- Dyslexia programs that are aligned to structured literacy or grounded in Orton-Gillingham methodology

Division approval committees for K-2 foundational skills, reading intervention and dyslexia programs is ongoing. All core program review has shifted to EdReports through our partnership.

## **Program Evaluation and Approval**

By the beginning of the 2021-22 school year

# Any public school district, including open enrollment public charter, that purchases a curriculum program shall choose a program from the approved list of curriculum.

A curriculum chosen that is not on the approved list shall submit a rationale for the choice, evidence-based research for the alternate program, and a signed letter from the Superintendent and School Board President requesting approval for use of the program.

# A public school district receiving Level 3, 4, or 5 support for reading may only choose a program from the approved list and may not choose an alternative program.

Fall 2022 Curriculum Audit will be conducted through educational cooperative specialists and compiled by DESE




# Partial Rebound of Reading Scores 2021-22




#### K-2 Growth









### Data for Schools in Level 3, 4, and 5 Support 2021-22

DESE Support Teams worked with all schools in coordinated, directed, and intensive support during the 2021-22 school year. <u>DESE Plan of Support</u>

#### Based on 2021-22 ACT Aspire data:

- 72% decreased the number of students in need of support
- 90% increased the number of students meeting readiness
- 18 districts moved out of Level 3 support

#### Based on other data collected:

• 69% of districts in support have adopted HQIM
