Amy Eakin, Director of Technology, reports on the following:

### **Track 1: Operational Improvements**

#### ***Initiative: Optimize Business Practices***

1. Agenda Items:
  - a. Approval of E-Rate Central FY26 MOA
    - i. Same cost as last year – no increase to be paid from General Funds
    - ii. Assist with E-Rate RFPs, funding acquisitions, audits
    - iii. Brought in over \$19M in revenue this year
  - b. Purchase Award; E-Rate
    - i. Category 2 RFP Highest Scored Bidder – Intellitech
    - ii. Order is for regionwide access points
    - iii. \$119,340 total cost with an E-Rate discount of \$100,726.13 and \$18,316.87 from Technology Capital funds.
    - iv. Order will expend all Category 2 funds allocated to the NWABSD for the 2020-2025 funding window.

3. House Joint Resolution 6
  - a. Resolution to support safeguard the Universal Service Fund at the Federal level
  - b. February 3 - Amy Eakin provided testimony to the House Labor and Commerce Committee on behalf of the District and NWALT along with a Maniilaq doctor.
4. Cybersecurity and Data Protection Implementation
  - a. Working through implementing KnowBe4 for ongoing training for all staff through email test spam
5. PowerSchool Breach
  - a. On Tuesday, January 7, 2025, PowerSchool informed our leadership team that they experienced a cybersecurity incident involving unauthorized access to certain PowerSchool SIS customer data.
  - b. NWABSD confirmed that NWABSD data was breached even though PowerSchool does not host the data.
  - c. Immediate action was taken to prevent similar future breaches
  - d. Notification was sent to all affected current students, staff, and parents via email, letters home, the website, and Facebook.
  - e. 13 staff members and 102 former ATC students had social security numbers involved in the breach

- i. Putting SSNs into the NWABSD PowerSchool system is not a practice, and steps have been taken to make sure no future staff are able to enter social security numbers into the system
- f. PowerSchool is offering **two years of complimentary identity protection** services for all current and former students and educators whose information was determined to be involved. They are also offering **two years of complimentary credit monitoring services** for all adult students and educators whose information was determined to be involved. PowerSchool is doing this regardless of whether an individual's Social Security Number was exfiltrated.

Additional work completed:  
November 6, 2024 – February 14, 2025

- **Districtwide Staff Transitions**  
Facilitated districtwide staff transitions by creating accounts for new hires and internal transfers. This included setting up Active Directory (AD) profiles, configuring email accounts, applying Microsoft licensing, and implementing specific Teams policies.
- **Districtwide Student Account Management**  
Managed districtwide student changes by creating accounts for new students and processing student transfers. This involved setting up Active Directory (AD) profiles, configuring email accounts, applying Microsoft licensing, and implementing staff/student-specific Teams policies.
- **Single Sign-On (SSO) Integration**  
Enabled Single Sign-On (SSO) across key educational platforms, including Verkada Command, enhancing user access and streamlining login processes.
- **ClassLink Rostering**  
Managed rostering in ClassLink for various platforms, including the Alaska Career Information System, Clever, and Mathia, ensuring accurate and up-to-date access for all users.
- **eRate-Funded Network Upgrades**  
Deployed Category 2 eRate-funded network upgrades across multiple sites:
  - Kiana: Replaced 5 network switches.
- **Verkada Camera System Deployment**  
Assisted with the deployment of the Verkada camera system in Noatak. Assisted with the troubleshooting Verkada on two buses. We have ordered an external AP for this site and will coordinate with the maintenance team for installation.
- **DRC Assessment (Student Assessment System)**  
Deployed updated Ubuntu 24.04 and installed Central Office Servers at the following sites: Ambler, Buckland, Deering, Kiana, Kivalina, Kobuk, Kotzebue, Noatak, Noorvik, Selawik and Shungnak.
- Deployed DRC Insite client software for ELL assessment to ~25 computers across the region.
