## **ADDITIONS:**

## **Extra/Co-Curricular Participation:**

A student MUST BE in school the entire day in order to participate in any extra/co-curricular activity. The following table defines the various attendance codes within JMC; items in purple qualify as excused absences resulting in the student remaining eligible to participate in extra/co-curricular activities.

## **Senior Attendance Requirement:**

Students must maintain a 90% attendance rate during their senior year – (refer to the "Attendance Code Key" found on page (#) for a list of absences that are excused (in purple) under this policy). Failure to meet this requirement will result in students forfeiting the opportunity to participate in the graduation ceremony.

#### **EDITS:**

#### **Cell Phones & Electronic Devices:**

Should students violate this policy, the following steps will be implemented – First Offense – teacher reteaches expectations and secures the phone away.

#### **Previous:**

Should students violate this policy, the following steps will be implemented – First Offense – teacher redirects student to put phone away (return it to the locker).

## Solicitation of Funds (Sales & Distribution):

A student may not solicit contributions or collect funds for any purpose - including displaying, distributing, selling of any items - from students or school personnel on school property, at school sponsored events, or on school transportation without prior approval from the principal.

#### **Previous:**

A student may not solicit contributions or collect funds for any purpose from students or school personnel on school property, at school sponsored events, or on school transportation without prior approval from the principal.

A student may not display, distribute, offer to sell or sell any item to students or school personnel on school property, at school-sponsored functions, or on school transportation without prior approval from the principal.
