**Goal:**

To replace the 36,000-gallon fire water storage tank at transportation in Pahrump.

**Discussion:**

The existing 36,000-gallon fire water storage tank at the Pahrump transportation yard has reached the end of its useful life. The tank, which is the original, has developed significant rusting around the water line, leading to leaks. As a temporary measure, the water level has been lowered to prevent further leakage. However, approval is now being sought to proceed with the replacement of the tank.

The replacement project will involve the installation of a new steel tank, equipped with a rubber liner to prevent corrosion. The new system will be supported by a reinforced concrete slab and feature updated connections for the Fire Department to ensure proper functionality. Additionally, the contractor will provide a temporary fire water storage tank to maintain operations during the project.

**Timeframe:**

The project is set to begin immediately upon receiving approval. We will coordinate between the contractor and the Transportation Department to ensure there are no disruptions to the bus routes during the construction period. Once the new tank is onsite, the contractor anticipates completing the project within approximately two months.

This timeline will allow sufficient time for the necessary construction, installation, and testing of the new tank while minimizing any operational disruptions.

The undersigned hereby proposes and agrees to furnish any and all required labor, material, equipment, transportation, and services for the work for the subject project in strict conformity with the Instructions to Bidders, the General Conditions, the Supplementary Conditions, Drawings, and Specifications entitled "TRANSPORTATION BUILDING FIRE WATER SUPPLY TANK REPLACEMENT PROJECT", and the Addenda numbered \_\_\_\_\_ as well as the premise and conditions effecting the Work.

BID SCHEDULE: Includes all work required to prepare the existing type-2 or similar sub-base material, including scarification, compaction to 90%, form, place, and pour the 4,500 PSI concrete foundation support for the tank, remove and dispose of existing firewater tank, provide and install new firewater tank per the drawings A0.1 and A1.1 through A1.4 entitled "TRANSPORTATION BUILDING FIRE WATER SUPPLY TANK REPLACEMENT PROJECT", including the tank and liner plus all fittings, ladders, etc. with the intent of providing a fully-functional firewater system as listed hereinafter for the sum of:
