## **Clarifications**

#### General

- 1. This GMP for the LCISD- Early Release HVAC Package is based on the contract drawings prepared by Corgan, Wylie and DBR and released on 2/17/2023. See the Document Enumeration Section for a complete list of documents. All other documents and agreements between the Owner and Gilbane are excluded.
- 2. The purpose of this GMP is to release specific long lead HVAC related Material and Equipment. Pricing is for the cost of material only and a subsequent GMP will be presented for price of install of each unit.
- 3. This GMP includes pricing only for the listed material in the GMP breakdown on Page 3 for Lamar Consolidated High School and Pink Elementary School. All other Schools and Areas as part of the LCISD Blue Track Additions and Renovations Project are excluded from this GMP.
- 4. The GMP is based upon open, competitive bidding by the suppliers listed in the Contract documents.
- 5. Upon approval of this GMP. LCISD will produce a Letter Of Intent to each successful supplier which will release the supplier to begin the shop drawing process and secure a spot in line for production.

#### Insurance and Taxes

Insurance and taxes are clarified as follows:

LCISD is a tax exempt entity.

General Liability insurance, Payment and Performance Bonds, and Builder's Risk Insurance are included in the 8.3% General Conditions at the following rates:

GL Insurance - \$6.95/\$1000 x Total Project Cost

Builder's Risk Insurance – An estimate of \$75,000 is included. This amount will be adjusted once final scope of work is defined and the policy can be purchased from the insurance market.

Payment and Performance Bond - .6% x Total Project Cost

### Contingency

We have not included a Contingency in GMP 1 since it is just an early equipment purchase. A Contingency will be included in future GMP amendments as required.

#### **Allowance**

With the volatility in the market in regards to Supply Chain we have included an allowance in the amount of \$1,250,000 which will be used in the event of any issues with securing material with this scope.
