BACKGROUND AND SIGNIFICANT ISSUES: On December 3, 2013 the Region One Education Service Center Board of Directors met to review and approve Region One Purchasing Cooperative Fire, Law Enforcement, Public Safety, Security – Equipment, Supplies, Systems, and Repairs Proposal 14-11-05, effective January 1, 2014 through December 31, 2015, with the option to extend up to two (2) additional one-year terms, if all parties are in agreement.
