Ms. Olson: Consider having electives, that way our honor students won't feel compelled not to take the classes because there would be no negative impact on their GPA. It is good having negative impact on students who in academic classes reach and are successful.

So we wouldn't want to take that away from students. So the proposal to have an honors track and a cp track seem to make more sense. What we envision right now is having Ms. Reilly coach the class with Ms. Minardi. Blended classroom of cp and honor students together. All students would have the same expectations for work. However, the honor students would have an additional responsibility that would rise to the level of honors quality work. And the benefit of it would be, Mr. Izzo listen up, no cost to the district because they already here on staff, Ms. Reilly already has a free period. She's in the library media center. So this is really part of a larger school wide conversation about how we really get access to all students and the type of programming interesting to them that's exciting and that meets our academics and personal means. Thank you very much for the opportunity.
